Verification For Kindergarten Applicants NOT Enrolled in a Preschool or Universal Transitional Kindergarten (UTK) Program

SAS Application and Verification Process for Applicants NOT Enrolled in Preschool/UTK

STEP 1: Go to the Choices application at **GoTo.LAUSD.net**. Select Apply Now and complete the application. Note your Confirmation/ Application ID Number.

STEP 2: Email Gifted/Talented Programs at <u>GATE@lausd.net</u> by Friday, November 17, 2023. Include in the subject line:

• SAS Kindergarten: [Student Name], [Confirmation/Application ID Number]

Indicate that your child is not enrolled in a preschool/UTK program and will need to be verified by Los Angeles Unified personnel.

STEP 3: Compile the following portfolio:

A: A brief one-page **letter of support** (completed by parent/guardian or another adult with firsthand knowledge of the child) addressing the skills and characteristics that would allow your child to succeed in SAS. Parents/guardians have unique opportunities to see their children at play, at work and in family settings. Your observations will help us better understand your child's strengths. Please include student name, Confirmation/Application ID, incoming grade, parent/guardian name and email in your letter.

B: Five pieces of evidence which support your child's advanced skills and characteristics in the areas listed on the *Eligibility Exemplars* document. Evidence may include: work samples (e.g., writing, math, art, projects), photographs, audio/video recordings (one minute maximum) to illustrate the critical thinking and problem-solving skills outlined in the Eligibility Exemplars document.

Thank you for your interest in applying to Los Angeles Unified Schools for Advanced Studies (SAS). To be accepted to an SAS site, your child must first be verified as eligible by demonstrating the requisite skills/characteristics needed to succeed in this setting. Since your child is not enrolled in a preschool/UTK program, this guide, which outlines the SAS verification of eligibility process, is provided. For your child to be considered for verification, please adhere to the directions and submit the portfolio to Gifted/ Talented Programs, Advanced Learning Options, by the deadline of Friday, November 17, 2023. Submission guidelines/recommendations are explained on page 2.

PLEASE NOTE: Participation in this process does not guarantee that your child will meet SAS eligibility criteria and/or be accepted to an SAS site. Additionally, this verification process is <u>NOT</u> an assessment for gifted identification.

THE PORTFOLIO MUST BE RECEIVED ELECTRONICALLY (<u>OR</u> POSTMARKED) BY FRIDAY, NOVEMBER 17, 2023. Please note that a receipt will be sent for portfolios emailed to <u>GATE@lausd.net</u>. No receipt will be provided for portfolios sent via U.S. Mail.

STEP 5: Between November 2023 and January 2024, a brief follow-up meeting (virtual or inperson) with you and your child may be scheduled if additional information is needed. If needed, the follow-up will be approximately 15 minutes and conducted by two members of the District's Gifted/Talented Programs staff.

STEP 6: The District Review Team will consider the **letter of support**, **5 pieces of evidence**, and **follow-up meeting (if applicable)** to determine if Kindergarten SAS Eligibility Criteria 1 (page 3) and Kindergarten SAS Eligibility Criteria 2 (page 4) have been met.

STEP 7: In February 2024, you will receive a Program Eligibility Letter from Unified Enrollment

notifying you if your child has met Kindergarten SAS Eligibility Criteria. <u>All decisions are final</u>. Eligible applicants will be included in the SAS selection process if a Choices application was submitted by the deadline. In March 2024, you will receive a Selection/Waiting List Letter.

SAS Kindergarten Eligibility Criteria 1: SAS Kindergarten Readiness Checklist

verifies that your child demonstrates the ability or strong potential to work two years above grade level in academic subjects. At least **TEN** of the **TWENTY** skills and characteristics listed below must be met:

SAS Kindergarten Readiness Checklist Skills and Characteristics

- 1. Works independently with evidence of goaldirected behavior
- 2. Uses descriptive words in sentences and uses language to express emotion, ideas, and opinions (in primary language)
- 3. Tells or retells a story with detailed description and expression
- 4. Recognizes and repeats complex patterning sequences and creates their own patterns
- 5. Follows multi-step directions with little guidance or redirection
- 6. Identifies the letters A to Z, knows the sounds of all of the letters of the alphabet and writes many of the letters
- 7. Counts aloud to 100, visually identifies numbers 1 to 100 and writes numbers 1 to 25
- 8. Demonstrates innate or accelerated understanding of addition, subtraction, multiplication and division
- Remembers information and experiences (e.g., recites song lyrics, recalls facts, etc.) and makes connections
- 10. Recognizes sight words and reads with fluency and comprehension
- 11. Demonstrates strong concern for others and their feelings and/or has a strong sense of justice
- 12. Initiates play sessions, coordinates and integrates multiple complementary roles and considers the actions of others
- 13. Uses unconventional objects in play activities
- 14. Interacts easily with peers; is frequently sought out by peers for companionships, ideas and decisions

SAS Kindergarten Verification of Eligibility Criteria 1 and Criteria 2

SAS Kindergarten participants must meet **both** of the following eligibility criteria – Kindergarten SAS Eligibility Criteria 1 (SAS Kindergarten Readiness Checklist) and Kindergarten SAS Eligibility Criteria 2 (Critical Thinking and Problem-Solving Skills). For the current application period, you will be asked to submit a **portfolio** of **five** items which reflects your child's advanced skills and characteristics. These items may reflect any of the skills listed here. Please refer to the **Eligibility Exemplars** for portfolio ideas. The *Eligibility Exemplars* document is not comprehensive, and you may create your own portfolio items that are not on the list. Please note that each piece of evidence (e.g., work sample, audio/video recording) may demonstrate multiple skills, characteristics and critical thinking/problem-solving skills.

- 15. Demonstrates a mature sense of humor; responds to and creates riddles and verbal associations
- 16. Demonstrates evidence of reasoning, logical thinking, creativity and spontaneous incorporation of academic activities into free play
- 17. Expresses ideas, seeks information through questioning and enjoys interacting verbally with adults and older children
- 18. Demonstrates advanced task commitment and energy when learning.
- 19. Remembers complex information and decodes symbolic systems (e.g., maps, codes, etc.)
- 20. Demonstrates curiosity; displays unexpected depth of knowledge in one or more areas

<u>AND</u>

SAS Kindergarten Eligibility Criteria 2: Critical Thinking and Problem-Solving Skills

In addition to Eligibility Criteria 1, your child must meet **ALL FOUR** of the following critical thinking and problem-solving skills in their primary language.

- 1. Explains meanings or relationships among facts, information or concepts that demonstrate depth and complexity
- 2. Formulates new ideas or solutions and elaborates on the information
- 3. Uses alternative methods in approaching new or unfamiliar mathematical problems
- 4. Uses extensive vocabulary easily and accurately to express creative ideas

To be verified as eligible for SAS Kindergarten, both Criteria 1 <u>AND</u> Criteria 2 must be met.
