



Status on Individualized Education Program (IEP) Team Meetings

During this global pandemic, LAUSD and the Division of Special Education continues its commitment to holding IEP team meetings in a timely manner. As of 6/2/22, LAUSD has conducted approximately 109,100 IEP team meetings during the 2021-22 school year. Parents are encouraged to participate in IEP team meetings, in-person, virtually and/or via telephone, and if there are any questions on how to do so, they are encouraged to reach out to their child's case carrier or the school administrator. The District is continuing to send text message reminders to parents regarding scheduled IEP team meetings and reminders on returning the IEP consent page (either in agreement or disagreements to all or part of the IEP). Parents can use Adobe Sign to electronically sign IEP documents such as the IEP consent page and notification to participate in IEP team meeting form. Extended School Year (ESY) (June 27, 2022 to July 22, 2022)

In accordance with California Code of Regulations, Title 5, Section 3043(d) and 34 C.F.R. section 300.106, LA Unified will offer an extended school year during the summer of 2022.

The ESY Student Enrollment window is from February 22nd – June 1st. Parents may enroll their child on the Parent Portal. Please refer to the ESY webpage for more information, including the ESY brochure, frequently asked questions and the ESY Student Enrollment flyer.

For enrollment after June 1st, students can still enroll for ESY at their indicated ESY site starting June 24th. Parents/guardians can also confirm their child's enrollment status in the Parent Portal. Early results of the Parent Workshop Survey

The Division of Special Education distributed a survey to all families of students with disabilities. As of 6/1/22, we have received 977 responses, with 74% of those being parents. This survey is seeking input from families, educators and school administrators to generate future parent workshops that are aligned to the needs of our communities. The survey consists of 9 questions and will take about 3-5 minutes to complete. Consolidated results from all returned surveys will be reported publicly on the DSE webpage. <u>Division of Special Education Summer Enrichment Opportunities</u> - <u>Digital Tools and Social Skills</u>

Online summer enrichment opportunities are available for students in grades 2-12.

The Digital Tools enrichment will be 8 online sessions, Tuesday through Friday, from June 14–17 and June 21-24, from 9:00 a.m. – 12:00 p.m. for students in grades 2-8. Through this session, students will learn strategies to access grade-level text, write fluently, enhance math skills, and build skills to do work more independently

The Social Skills enrichment will be 10 online sessions, Tuesdays and Thursdays, June 20-July 22, from 2:00-3:00 pm. Students in grades 3-5 will participate in Social Emotional Learning. Students in grades 6-12 will participate in Peer Debates. Throughout these sessions, students will engage with teachers and peers to explore their emotions, become more self-aware of their triggers and responses, and learn to better self-manage. Whole group discussions will be reinforced by small peer group presentations to enhance perspective taking and students' social communication skills.

COVID-19 COMPENSATORY EDUCATION PLAN

What is the COVID-19 Compensatory Education Plan?

Students with disabilities are entitled to a free appropriate public education (FAPE).

The COVID-19 pandemic had a negative effect on schools resulting in learning disruption nationally. Students with disabilities may need Compensatory Education services to remedy any educational or other deficits that resulted from a student with an IEP or Section 504 plan not receiving the evaluations or services to which they were entitled during the COVID-19 pandemic. Students with disabilities may also need Recoupment Services to regain skills lost resulting from pandemic learning disruptions.

The Los Angeles Unified School District has implemented two approaches for processes for addressing the impact of the COVID-19 pandemic:





Compensatory Education- special education and related aids and services to remedy any educational or other deficits that resulted from a student with a disability (with either an IEP or Section 504 plan) not receiving the evaluations or services to which they were entitled during the COVID-19 pandemic. SELPA/CDE Information

Students with Disabilities and Face Coverings

The purpose of this notice is to provide an update for local educational agencies (LEA) of the current state guidance regarding face coverings, including allowable exemptions in order to avoid implementing policies that may result in a denial of a free and appropriate public education.





LEAs must continue to adhere to least restrictive environment requirements of the Individuals with Disabilities Education Act (IDEA) when educating students with disabilities, including ensuring students with disabilities are educated with their nondisabled peers to the maximum extent appropriate (34 Code of Federal Regulations § 300.114). It is imperative that students with disabilities not be excluded from educational environments should their disability require a school-related health service. Although there is no longer a statewide mask or face coverings mandate, masks and face coverings are still strongly recommended by the California Department of Public Health (CDPH). Both the Centers for Disease Control and Prevention (CDC) and the CDPH strongly recommend school-wide layered prevention strategies to preserve in-person learning.
