I. Call to Order

X. Consolidated Application and Federal Addendum Overview

- Q Are arts funded? A- Arts get funding through other sources.
- Q How are we keeping standards high for teachers? A- Working teacher recruitment and retention. Communicating with universities for outreach and referrals.
- C- Highschool students need more social emotional support during the college application process.
- Q- Is there a system that requires teachers to complete PD? A- Some PD is required but not all. Some school sites offer compensation but not all. Best to organize at a local level based on student needs.
- Q- Translation isn't offered, why not? A- Translation laws don't apply for oral translation. Agrees that this is not acceptable and encourages advocacy on the matter.
