Any individual wishing to address the Board must register to speak using the Speaker Sign Up website: https://boardmeeting.lausd.net/speakers, and indicate whether comments will be provided over the phone or in person. Registration will open 24 hours before the meeting. Each action item will allow for 10 speakers, and 20 speakers may sign up for general Public Comment. Speakers who sign up for an action item will have two minutes to provide comments, and speakers who sign up for general Public Comment will have two minutes to provide comments.

Public comment can be made in-person or by telephone only, and members of the public must sign up online for either method, as described above. Members of the public can only make remote public comment by calling (888) 475-4499 and entering the Meeting ID: **832** 3386 6360

Each speaker will be allowed a single opportunity to provide comments to the Board. Speakers signed up to speak on an agenda item must constrain their remarks specifically to the item or items on the agenda or may be ruled out of order.
