POLICY: Los Angeles Unified is committed to support schools and offices as they

maintain a safe and welcoming Learning environment.

Emergencies and disasters can strike anywhere and at any time. District employees may be required to deal with an emergency when it is least expected. Proper planning *before* an emergency is necessary to respond effectively.

MAJOR CHANGES: This is a new policy of Los Angeles Unified. It provides procedures and guidelines to protect students, employees, and the public during an event, such as athletic/special events held at a District facility or sponsored by the District. A carefully developed emergency action plan guides responses when immediate action is necessary. Planning in advance helps ensure that everyone knows what to do when an emergency occurs.

**GUIDELINES:** 

The purpose of this communication is to review and refine District protocols during athletic/special events to prepare for and respond to emergencies. It is critical that at athletic/special events staff are aware and prepared for these situations so they can immediately take appropriate actions even before first responders arrive. To best prepare staff for athletic/special events emergencies, school administrators/designees hosting athletic/special events should ensure the following actions take place:

#### I. BEFORE ATHLETIC/SPECIAL EVENTS

#### All Incident Types: General Preparedness

A. The hosting school site administrators, staff, and stakeholders should engage in planning for emergency situations, including an active shooter incident. Planning for emergency situations will help to mitigate the impact of an incident.

- B. School administrators/designees may utilize Attachment A Emergency/Medical Action Plan (EMAP) to assign responsibilities to staff before the event.
- C. Create an athletic/special events Emergency/Medical Action Plan (EMAP) that includes:
  - Reporting emergencies to 9-1-1 system;
  - Evacuation policy and procedures for staff, student-athletes, and community members via pre-planned evacuation routes to a safe area utilizing the School Site Safety Plan and the Integrated Safe School Plan (ISSP) if the event is taking place off-campus;
  - Ensuring that the school site has at least two (2) evacuation routes listed in the ISSP:
  - Posting evacuation routes in conspicuous locations throughout the school or the athletic/special event site;
  - Ensuring an adequate number of staff equipped with the necessary keys such as emergency bins and gate keys;
  - Contact information for individuals with specific listed responsibilities;
  - Local hospital or pediatric trauma center information (i.e., name, telephone number, and distance from the location);
  - Emergency notification protocols to alert various parties of an emergency including:
    - a. Individuals at remote locations on premises
    - b. Local law enforcement agency
    - c. Medical professionals staffing event
  - Assigning staff member(s) to lock doors and gates; and
  - School administrators/designees may utilize Attachment A Emergency/Medical Action Plan (EMAP) to create their own EMAP if necessary.
- D. Plan to assist individuals with access and disabilities/physical needs:
  - Ensure that athletic/special events EMAP has evacuation instructions and any other relevant protocols that address individuals with access and disabilities/physical needs; and
  - The athletic/ special event site should be accessible and in compliance with the American with Disabilities Act (ADA) requirements.
- E. Promote reporting signs of potentially violent or suspicious behavior.



Staff may call Los Angeles School Police Department (LASPD) – Watch Commander at (213) 625-6631 or report it through the Los Angeles Schools Anonymous Reporting (LASAR) mobile application.

- F. If unfamiliar with the athletic/special event site, conduct a pre-event walkthrough to address any possible dangers/hazards. Identify exits, ingress/egress, bus area, restrooms, etc. to better inform and refine plans.
- G. Prepare an announcement and test the Public Address (PA) system. See Attachment B Sample Public Address (PA) Announcement at Athletic/Special Events.
- H. Update the school's supervision plan for the athletic/special events using Attachment C School Athletic/Special Events Supervision Plan.
  - Consider:
    - a. Ingress/Egress (including for emergencies and accessibility);
    - b. Line(s) of sight for supervision;
    - c. Restrooms available to attendees;
    - d. Access controls (i.e., keys, security system passcodes, etc.); and
    - e. Contacting the Region Operations to review the plan.
  - Thoroughly review the school's supervision plan with Region Operations and/or LASPD staff who will assist during the athletic/special events.
  - Review the plan with supervision staff, ensuring:
    - a. Sufficient supervision staff are available and seek support from the Region, as necessary;
    - b. Test communication system (e.g., radios, PA system, etc.); and
    - c. Transportation logistics are in place and communicated with key staff (i.e., bus parking, routes in/out of athletic/special events, supervision, etc.).
- I. Identify separate bathroom and locker room facilities for the visiting team, if feasible.
- J. Notify/contact LASPD for awareness of the event to request additional staffing as needed and discuss additional safety measures or specific concerns. Circumstances where support should be requested include:
  - Traditional rivalry games or other high-profile contests.



- Ongoing community unrest.
- Concerns related to students' or attendees' safety.
- K. Communicate expectations with the student body and prospective attendees through:
  - Blackboard Connect messages in the days leading up to the athletic/special events. See Attachment D – Blackboard Connect Template Messages for Athletic/Special Events
  - Post large signs before and during the athletic/special events with protocols such as, "No In & Out" (entry/exit)
- L. Train and exercise the above plans by including school administrators, staff, and first responders.
- M. Be mindful of threat and violence indicators and take steps to mitigate accordingly. This may include notification to LASPD or other local law enforcement agencies.
- N. Assemble and distribute critical items to appropriate employees, including:
  - Radios
  - Automated External Defibrillator (AED) locations
  - Floor plans, including campus/facilities
  - Keys, including the school emergency bins
  - First aid kits and emergency bins locations
  - Flashlights
  - Staff roster and emergency contact numbers
  - Facility personnel lists and telephone numbers
  - Emergency/Medical Action Plan (EMAP) and supervision plans
- O. If the athletic/special event is not at a Los Angeles Unified site, coordinate with that facility's security department to ensure the physical security of the location and to inform your plans of action, including EMAP and supervision plans.

### II. DURING ATHLETIC/SPECIAL EVENTS

- A. Publicly announce, using the PA system, to event attendees, general emergency procedures and exits. See Attachment B Sample Public Address (PA) Announcement at Athletic/Special Events.
- B. During an emergency, the school administrator/designee of the event becomes the lead. Employees, students, and community members



should follow the lead's directives. The school administrator/designee should be familiar with the EMAP and be prepared to:

- Take immediate action based on the situation;
- Remain calm;
- Continue to assess the situation and provide updates to appropriate staff; and
- Follow first responders for non-violent emergencies and law enforcement guidance and collaborate with Region staff.

## C. All Incident Types – General Event Actions:

- Have staff wear District-approved vests visibly at all times to easily identify them for needed support.
- Maintain ongoing communication with all staff throughout the athletic/ special event.
- Reiterate to all staff to be aware of their environment.
- Post clear signage throughout all impacted areas of campus, including clear No "In & Out" signs.
- Engage in active supervision:
  - a. Know established egress routes and exits near post signs;
  - b. Dialogue with students and other attendees; and
  - c. Alert other staff immediately of any possible issues/
- All staff should know points of contact for support:
  - a. On-site administrator/designee.
  - b. Region Operations contact information (if not on-site).
  - c. LASPD (if not on-site).

## D. If an emergency/incident occurs:

- Contact LASPD and Region Operations immediately, if not already present;
- Use the PA system to give specific instructions to teams and spectators, if safe to do so:
- Support visiting team with safe passage before and after the event as needed between bus/parking lot and gym/court/field
- Activate the emergency notification protocols as described in the EMAP; and
- Activate assembly area(s), provide support, and create rosters of players and student spectators unaccompanied by parents.

### III. AFTER ATHLETIC/SPECIAL EVENT INCIDENT

### All Incident Types: General Recovery Actions:

- Meet with staff for at least 10-15 minutes (or longer if necessary) to debrief the incident after the athletic/special event incident ends.
- Notify parents via Blackboard Connect message of any incident as appropriate.
- File an iSTAR to document any incidents (e.g., injuries, disturbances, etc.).
- On the first school day after the incident, schedule an After-Action Review meeting, as needed.
- Ensure that students are provided with any follow-up support (e.g., mental health, medical, etc.).

Following a significant incident, the Division of School Operations and the Region Operations will convene a team that will conduct an After-Action Review meeting and summarize key information regarding the incident and response measures taken. The review will include staff and responder performance and recommendations for next steps.

#### IV. OTHER EMERGENCY RESPONSES

Attachment E – Other Emergency Responses Definitions will guide and provide school administrators/designees with an understanding of other emergency responses.

## **Lockdown Due to Trespasser and Weapon Found on Campus**

## Multiple Lockdowns/Final Message/Extra Resources/Firearm Sighting

Dear Parents/Guardians,

As the principal of [name], the safety and well-being of our students and our staff remains my top priority.

We appreciate your patience today while we dealt with an incident that caused the lockdown of our campus. Our campus remains open and safe for instruction.

Earlier today, a member of our school community reported a possible firearm sighting. We immediately placed the campus on lockdown and a thorough investigation was conducted with the assistance of the Los Angeles Police Department and the Los Angeles School Police Department. Our local law enforcement partners (and School Police) conducted a thorough search of our campus and no weapons were found. Our campus is no longer on lockdown.

We take the safety of our students very seriously. In an abundance of caution, the Los Angeles School Police Department will have a police officer stationed at our campus for the remainder of the semester in addition to extra patrols around our campus. Our partners at LAUSD Region North will be providing support from Los Angeles Unified to ensure the safety of our school community with extra support staff.

Our school will also provide resources for students who may need additional mental health support because of this incident. Please contact us at direct phone number for on-campus school mental health resources to learn more about how we may support your child.

### Other Emergency Responses Definitions

POLICY BULLETIN

### A. Fire Evacuation (Fire on or directly threatening campus)

This action provides protection if a school building or an adjacent area is burning. Teachers should be familiar with the approved path of travel from the evacuation map in their classrooms and notify the principal if there is no evacuation map.

## B. Drop/Cover/Hold On (Earthquake)

This action provides maximum protection during an earthquake or other emergency where the risk of flying or falling debris is present. There is typically no advance warning or signal given. During earthquake drills, teachers should supervise students and be alert to the position of each student during the entire drill.

### C. Lockdown (Violence/threat of violence on or near campus)

This action is taken when the threat of violence or gunfire is identified or directed by law enforcement, and it is necessary to prevent the perpetrator(s) from entering any occupied campus areas. This action is to secure the school during police actions, campus intrusions, community incidents, or other real or perceived threats to the security of the school. During a lockdown, students are to always get to and remain in locked classrooms or designated safe locations.

## D. Shelter-in-Place (Outdoor airborne contaminant or other hazard)

The Shelter-in-Place action protects students indoors from airborne contaminants or other environmental dangers that are present outside. Shelter-in-Place includes the shutdown of classroom and building Heating, Ventilation, and Air Conditioning (HVAC) systems, as no one should be exposed to outside, contaminated air. Ensure that multiple people on campus are trained and designated to shut off all HVAC systems in the event of an incident and that these members practice the shutdown procedures each semester. Schools are encouraged to clearly label shut-off switches so that they will be easy to find and operate, and pictures of switches and shutdown directions can be stored in a binder with a school map and uploaded to the ISSP for the Security/Utilities emergency team.

The difference between Shelter-in-Place and Lockdown is that a Shelter-in-Place includes the shutdown of HVAC systems and allows for the free movement of students within a building. However, classes in bungalows and buildings with exterior passageways will have to remain in the classroom during a Shelter-in-Place.
