## **INFORMATION RELEASE FORM**

Parents of students 17 years or younger and adult students 18 years or older may request to limit the release of student directory information or to not release directory information at all. Pursuant to California Education Code Section 49073, the District has identified the following categories of information as student directory information that may be released to authorized individuals, organizations, and officials: name, address, phone number, date of birth, current and most recent previous school(s), dates of attendance, and degrees, honors, and awards received.

The request to limit or withhold student directory information is applicable only to the current school year and must be submitted annually. If you wish to limit or prevent the release of student directory information, please complete and sign this form and return a copy to your school principal by Friday, November 14, 2025. If this form is not completed, signed, and returned to your school principal by this date, your child's directory information may be released in accordance with Federal and State law.
