#### **VENDOR INSURANCE LIMITS:**

#### **COMMERCIAL GENERAL LIABILITY**

Per Occurrence Limit	\$1,000,000
Products & Completed Operations Aggregate	2,000,000
Personal & Advertising Injury	1,000,000
General Aggregate Limit	2,000,000
Fire Damage (Any One Fire)	100,000
Medical Payments (Any One Person)	5,000

#### **ABUSE & SEXUAL MOLESTATION\***

Per Occurrence Limit \$1,000,000
General Aggregate Limit 1,000,000

\*Vendors that will be in contact (Non-Incidental) with youth (18 & under) will require Abuse & Sexual Molestation coverage.

## **COMMERCIAL AUTO POLICY\*\***

Combined Single Limit

\$1,000,000

\*\*All owned, hired and non-owned autos must be covered. If there are no owned autos a signed Commercial Auto Liability waiver, and hired & non-owned coverage is required.

### **WORKER 'S COMPENSATION\*\*\***

Statutory

**Employer Liability** 

\$1,000,000

\*\*\* Sole proprietors with no employees are exempt from providing WC coverage, but must provide a signed waiver statement.

#### ERROR'S AND OMISSIONS (E&O)\*\*\*\*

Per Occurrence \$1,000,000 General Aggregate \$1,000,000

\*\*\*\*Errors and Omissions or Professional Liability coverage is required for all professional services and consulting contracts.

## **CYBER LIABILITY \*\*\*\*\***

Per Occurrence \$1,000,000 General Aggregate \$1,000,000

\*\*\*\*\* Required for services involving information technology, software development, database development and administration, etc...

The Commercial General Liability Policy, Abuse coverage, and the Commercial Automobile Policy <u>must</u> contain an Additional Insured Endorsement wording of:
