



**NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION AND  
NOTICE OF PUBLIC COMMENT PERIOD FOR  
PRELIMINARY ENVIRONMENTAL ASSESSMENT – EQUIVALENT**

**PROJECT TITLE:** Abraham Lincoln High School Comprehensive Modernization Project

**SUBJECT:** Notice of Intent to Adopt a Mitigated Negative Declaration and Notice of Public Comment Period for Preliminary Environmental Assessment-Equivalent for the Comprehensive Modernization of Lincoln High School

**Notice is hereby given** that the Los Angeles Unified School District (LAUSD or District), as Lead Agency under the California Environmental Quality Act (CEQA) has prepared an Initial Study (IS) for the Abraham Lincoln High School Comprehensive Modernization Project (proposed Project), pursuant to the CEQA (Public Resources Code [PRC], Division 13, Section 21000 et seq. [CEQA Statutes] and the California Code of Regulations [CCR], Title 14, Division 6, Chapter 3, Section 15000 et seq. [CEQA Guidelines]). Based on the conclusions of the IS, LAUSD determined that the proposed Project would have no significant adverse impacts on the environment after the implementation of mitigation measures and a Mitigated Negative Declaration (MND) is appropriate. The District is providing public notice in compliance with CCR Title 14, Chapter 3, Sections 15072 and 15073, as amended. Notice is further given that a Preliminary Environmental Assessment – Equivalent (PEA-E) has been prepared for the proposed Project and is available for review.

**PROJECT LOCATION:** The approximately 18.6-acre Lincoln High School campus is located at 3501 North Broadway, City of Los Angeles, Los Angeles County, California.

**PROJECT DESCRIPTION:** The proposed Project is designed to address the most critical physical concerns of the building and grounds at the Campus while providing renovations, modernizations, and reconfigurations. The proposed Project includes new buildings including a 2-story classroom building, performing arts building, Maintenance and Operations building, facilities for Pueblo de Los Angeles Continuation High School (modular buildings anticipated), and field house restroom building. The proposed Project also includes modernization of existing structures and site improvements including utility upgrades, access upgrades to meet programmatic requirements of the Americans with Disabilities Act, and landscape and hardscape improvements. The project includes demolition of the music building, storage building, shop building, Pueblo de Los Angeles Continuation High School (3 portable/relocatable structures), and 7 portable buildings. Pueblo de Los Angeles Continuation HS would temporarily be relocated to Glen Alta Elementary School during construction. The campus is not on any of the lists compiled under Government Code Section 65926.5.
