Quorum was met at 6:20. Commission approved April minutes.

Welcomed two new members – Joey Hernandez, representing Board Member Monica Garcia, and Anthony Eftimeo, representing ADL.

Suggested that agency updates be included as a standard agenda item.

ADL received an alert that unconstitutional bible clubs are at Sun Valley and Chatsworth. Judy will refer to Education Equity Compliance for follow up.

Discussed the role of the commission, possibilities of grants, book donations, leveraging resources.

Ethnic studies – Allan has been communicating with Office of Instruction and ad hoc ethnic studies advocates on status. There is a push to reopen meetings and the review process to the community at large.

UTLA agreed to amend existing agreement to include ethnic studies. Vote is on Wednesday.

Proposal to reconvene ethnic studies committee in a timely fashion and to revisit ethnic studies as an A-G requirement. Passed unanimously.

Chiasson has been collaborating with Curriculum and Instruction on teacher preparation to teach the ethnic studies classes. The Commission offered their resources.

Kakassy proposed revisiting the letter authored by Wittig & Toma. Critical selection represents the commission's core value: "Students learn about the intersectionality of our social selves. Our social identities vary along dimensions of gender, sexual orientation, abilities, religious beliefs, and accents or appearance, as well as ethnicity and race. All of these dimensions intersect with each other, and influence our view of ourselves, each other and our world. These identities are influenced by the histories, customs, and traditions of the groups to which we belong and they help shape our interactions with each other. However, our identities are constantly evolving, creating new opportunities for overcoming group boundaries. The growing proportion of students who identify multiracial is evidence of this evolution. "

Religious diversity, intolerance and extremism -

ADL, Judy Chiasson, and LAUSD library services collaborated on a book list of religious diversity, intolerance and extremism. Approved LAUSD vendors have the capacity to properly bind and catalog books. Reynolds is working with a donor on partnering with the district's approved vendors.

Human Relations, Diversity & Equity

Holly Priebe-Sotelo left LAUSD to accept a position at USC. Her position has been approved by the freeze committee to be filled.

In 2005, the following units addressed human relations and social justice: The Office of Human Relations, Diversity & Equity (1 director, 5 specialists, 1 classified), Youth Relations (16 classified staff) and Student-to-Student (8 credential staff). By 2007/08, all positions had been liquidated except for two human relations specialists.

Motion to establish a sub-committee to write a proposal to restore the staffing of the Human Relations, Diversity & Equity. Approved.
