SUBJECT: CULTURAL ARTS PASSPORT PROGRAM 17703 ALLOCATIONS FOR FISCAL YEAR 2027

The purpose of this correspondence is to provide Region Directors and principals with an update on the Cultural Arts Passport (CAP) Program 17703 allocation plan expectations and deliverables for Fiscal Year (FY) 2027. The purpose of the CAP allocation is to provide students with visual and performing arts-aligned experiences and learning opportunities outside of the regular school day as outlined MEM-156913.1 Cultural Arts Passport Program Guidelines, dated July 28, 2025. The CAP program offers all students the opportunity to engage in supplemental arts experiences such as field trips, on-campus performances, events, and workshops beyond the regular school day.

## **Allocations**

Schools will receive allocations during budget development based on (FY) 2027 e-cast enrollment data as specified below:

## CAP Plan Submission For The 2026-2027 School Year

In preparation for SY27 budget development, principals should complete the fillable Cultural Arts Passport plan located in the School Plan for Student Achievement (SPSA) platform, under the "Other Plans" section. To support schools with CAP Plan development on the SPSA platform, there is a job aide published in December and shared through the Weekly Instructional News, posted to the Arts Education Branch website at <a href="arts.lausd.org">arts.lausd.org</a>, added to the <a href="Cultural Arts Passport Toolkit">Cultural Arts</a> <a href="Passport Toolkit">Passport Toolkit</a> and the <a href="Arts Funding in Schools Communication Toolkit">Arts Funding in Schools Communication Toolkit</a>.

Please note that all CAP expenditures must support students' access to visual and performing arts experiences and learning beyond the school day. Appropriate planned after school expenditures may include: admission tickets and transportation, school productions (dance, theatre, music) and showcases and festivals (visual and media arts/film), visual and performing arts instructional materials, extra-duty pay (Nurse X-time, Teacher X-time, Clerical X-time, Custodial OT, etc.), contract services for Arts Community Network partners, Family and Community Arts events, and more. Expenditure guidance is flexible when adhering to CAP program goals and when justified appropriately in an approved CAP plan.
