Screen	Item	Details
School Details	ISSP Designee	This is now a required field. The ISSP designee may be a certificated or classified staff member. Principal can list self as designee if no appropriate staff member can fill this role. Note: This is not a new field, but it requires data entry by the school.
	Date Operations Coordinator and Principal Reviewed ISSP	New field for Operations Coordinator or Principal to specify date when they jointly reviewed the ISSP.
Step 1 (Planning Team)	School Safety Planning Committee	Clarified that for all schools receiving Title I funds, the School Site Council (SSC) shall write and develop the plan, unless the SSC delegates this responsibility to the School Safety Planning Committee. This SSC action needs to take place yearly in the spring semester and will take place the year prior to the fall ISSP development. For all schools not receiving Title I funds, the School Safety Planning Committee will develop the ISSP.
	School Safety Planning Committee	Clarified that the School Safety Planning Committee, if the SSC delegates to this body, should present the ISSP to the SSC by December.
	School Site Council	Added fields for schools whose SSC will develop/developed the ISSP so that they can identify the SSC members.
Step 2 (Assessments)	Health and Nutrition, Cardiac Arrest/Similar Life-Threatening Medical Emergency	Included District procedures for responding to incidents involving an individual experiencing a sudden cardiac arrest or a similar life-threatening medical emergency while on school grounds.

Step 4 (Develop Plan)	Charter School Emergency Team Assignments	New field for sites with co-located charter schools to upload a document listing charter school employee team assignments.
	Charter School Emergency Contact	Disabled replacement feature; once uploaded by the District this document cannot be replaced at the school level.
	Site-Specific Considerations	Added field for school to specify when entry was updated.
	Access and Functional Needs, Evacuation	Multiple-story schools should specify Evac+ Chair locations.
	Emergency Functions- Courses of Action, Functions	Added language about the District's established procedure to include an instructional continuity plan when in-person instruction is disrupted due to an emergency.
	Threats and Hazards- Courses of Action, Tsunami	Tsunami protocol updated.
Step 5 (Approval)	Approve the Plan	Signature pages are available for the School Site Council, if it developed the ISSP. Schools are provided both templates, School Safety Planning Committee and School Site Council.
	Signature Document Upload	Disabled replacement feature; once school uploads its signature page with all required signatures it cannot be replaced at the school level. Note: This is not a new field, but it requires uploading a document.
Step 6 (Train/Exercise)	ISSP Preview Session Date and Certification	Added fields for principal to certify that and specify date when they reviewed last year's ISSP and interim emergency team assignments with all staff during the August Pupil Free Day (see REF-5511 Completing and Updating the Integrated Safe School Plan for more details).
	<i>Every School Safe:</i> Mandatory Safety Training Modules Certification Table	Updated to reflect current year's topics, required audience, and due dates. This year this will include an additional ESS module titled, Integrated Safe School Plan, due by October 3, 2025. Note: These are not new fields, but they require data entry by the school.
Other	Steps 1-6	Prior school year's entries have been cleared; school must enter data in all required fields marked with an * and all others as applicable. Most steps will now initially show 0% completion.
	Charter School Emergency Contact	All fields excluding the charter school name and emergency contacts PDF (uploaded by the District) were eliminated.
	Tsunami Annex	Schools in the Tsunami Zone updated.
