SUBJECT: ABOLISHMENT OF UNUSED CLASSIFICATIONS

SUBJECT: VIRTUAL ACCESS TO PERSONNEL COMMISSION MEETINGS

RECOMMENDATION:

It is recommended that the Personnel Commission, upon its return to in-person meetings in accordance with the provisions of the Brown Act, continue to allow public comment and oral presentations by parties associated with appeal matters to be offered virtually.

BASIS OF RECOMMENDATION:

Since 2020, meetings of the Board of Civil Services Commissioners have been held virtually. Both public comment as well as Board presentations have been offered virtually using Zoom. With the lifting of the Governor's Emergency Order, the Personnel Commission will return to in-person public meetings in compliance with the Brown Act as contained in section 54950 et seq. of the state Government Code. It is expected that the March regular meeting will be held in person at Beaudry.

For two years, virtual meetings have allowed the public and parties associated with appeals access to provide their opinions or present their cases virtually. Members of the public and employees of the District would otherwise need to take off work and commute to a downtown location, where traffic and parking are often challenges. Additionally, there is no prohibition which would exclude these types of virtual participation of employees and members of the public. Opening up Personnel Commission meetings to both in-person and virtual participation will allow maximum access to the meetings for employees and the public.
