Reason for Reclassification: The subject position has been assigned duties that meet the class concept of Fiscal Reports Specialist in that the incumbent plans and coordinates the analysis and reporting of fiscal data related to budgets, costs, and financial forecasting. The incumbent reviews various budget models to propose fiscal solutions, and provides work direction to a Senior Financial Analyst and a Senior Fiscal Specialist in the Total Compensation Unit which is responsible for the accurate budgeting and reconciliation of staffing costs, developing strategies for cost savings, and deploying position management solutions including implementing necessary Financial System modifications. The subject position develops detailed competing cost scenarios for evaluation and selection by Senior Management prior to implementation of budget decisions. An example of the most recent, the incumbent participated in implementing the legally mandated funding administrator to teacher ratio (R2) by developing visual models of the effect of various possible Assistant Principal renorming plans by documenting multiple complex scenarios which were applied to sample schools to show staffing implications of the downward norming of Assistant Principal including key changes and cost savings. Manages enrollment driven norm staffing fluctuations at schools including reviewing appeals performing initial recommendations and creating informatives. Additional similarly complex past projects include calculating the cost of implementing potential collective bargaining unit agreements, documenting the effects of District reorganization (ESC to LD to CoS to Region), and coordinating staffing changes with HR and PC during RIF.

Status of Incumbent: Incumbent R. Ta (EN 794568) must compete in the examination for Fiscal Reports Specialist, be reachable on the resultant eligibility list and appointed to the reclassified position or be otherwise assigned. In the absence of an eligibility list, the incumbent may be provisionally assigned to the position pending the results of the examination.
