

# IDEA FULL FUNDING ACT FEDERAL ADVOCACY TOOLKIT 2024



Dear LAUSD Families, Students and Community Partners:

We invite you to join Los Angeles Unified in urging Congress to pass the IDEA Full Funding Act, which would fully fund the [Individuals with Disabilities Education Act \(IDEA\)](#) over 10 years and provide support to school districts as they ensure students with disabilities receive a free appropriate public education. Despite the federal government's promise to provide 40% of the extra costs associated with educating students with disabilities, it only covers approximately 16%. If the federal government had appropriately funded the IDEA mandate and provided the full 40% funding, Los Angeles Unified would have received approximately \$180-200 million additional dollars annually over the past several years. This funding is critical to meet the educational needs of this student population.
