**ORDER CONCLUDING AND
TERMINATING MODIFIED
CONSENT DECREE, AND
DISMISSING ACTION WITHOUT
PREJUDICE**

1 The Court, having considered the Parties “STIPULATION BETWEEN
2 PLAINTIFFS AND DEFENDANT LOS ANGELES UNIFIED SCHOOL DISTRICT
3 TO CONCLUDE AND TERMINATE MODIFIED CONSENT DECREE
4 PURSUANT TO SECTION 20 AND TO DISMISS ACTION WITHOUT
5 PREJUDICE,” and good cause appearing therefrom, hereby orders as follows:

6 1. Effective January 1, 2020, the management and control of the website of
7 the Independent Monitor (www.oimla.com) shall be transferred to Disability Rights
8 California to maintain as a historical resource. No later than January 15, 2020, the
9 following notice shall be placed on the website: “The Modified Consent Decree
10 (MCD) terminated on December 31, 2019. This website is being maintained as a
11 historical record of the MCD.” In addition, the contacts page shall be deleted.

12 Disability Rights California shall not otherwise add or delete, nor allow for additions
13 to or deletions from, the www.oimla.com except by written agreement with the
14 District, and shall not transfer or assign the management or control of the website.

15 2. The Independent Monitor shall close his office no later than December
16 31, 2019.

17 3. Effective December 31, 2019, the MCD is concluded and terminated.

18 4. Notwithstanding termination of the MCD, the District shall be obligated
19 to reimburse Plaintiffs’ counsel for all fees and expenses reasonably incurred through
20 December 31, 2019, in accordance with Section 19 of the MCD.

21 5. Effective December 31, 2019, the action (Case No. CV 93-7044-RSWL
22 (GHKx)) is hereby dismissed without prejudice.
