- Spring 2019 College & Career Readiness Survey**
 The College & Career Readiness Survey administration window is **Wednesday, May 1st through Friday, June 7th, 2019**. Students in **grades 9-12** will access the College & Career Readiness Survey via Naviance, where the survey will be assigned its own Naviance task. Students will see the link to the survey on their Naviance *Welcome* page. To access the survey, they simply have to click on the link and login by:
 1. Selecting their school's Local District (e.g., Central, East, South)
 2. Entering their 10-digit LAUSD ID

- Spring 2019 Senior Exit Survey**
 The Senior Exit Survey administration window is **Wednesday, May 1st through Friday, June 7th, 2019**. Seniors will access the Senior Exit Survey via Naviance, where the survey will be assigned its own Naviance task. When seniors log into Naviance, they will see the link to the Senior Exit Survey on their *Welcome* page.

 Students' survey responses will be available to counselors in real time through the Naviance system to identify students who need additional supports and to help ensure students successfully enroll in college in the fall. The entire Senior Exit Survey will take students approximately **5-10 minutes to complete**.
- Fall 2019 Computer-Based Initial and Summative English Language Proficiency Assessments for California (ELPAC)**
 LAUSD schools have been invited to participate in the fall 2019 computer-based (CB) Initial and Summative English Language Proficiency Assessments for California (ELPAC) field test.

Participation in the field test is voluntary, but schools are encouraged to participate so that students and teachers become familiar with the new CB ELPAC format.

By agreeing to participate in the field test, schools must commit to the following:

- Participate in the CB ELPAC field test during the field test window of October 1 through October 25, 2019
- ELPAC coordinator will participate in a one-day ELPAC administration and scoring training sponsored by the Student Testing Branch (STB) and the Multicultural Multilingual Education Department (MMED) in October 2019

- **MS: Computer Science Course Updates**

At the end of the 2018-19 school year, *Introduction to Computers* will sunset and be replaced with *Computer Science Discoveries* (180115 and 180116), *Introduction to Programming: Game Design and App Development* (180117 and 180118), *Introduction to Physical Computing* (180121 and 180122), or an equivalent Career Technical Education (CTE) computer science course for students in grades 6-8. These courses are aligned to the new California Computer Science State Standards.

- **ES: DIBELS Reminder Aim for Blue!**

The findings show that 90% of kindergarteners who scored Above Benchmark = “BLUE” at EOY on DIBELS maintained at Benchmark or above through the end of 3rd grade. Students who reach “BLUE” by end of Kindergarten are significantly less likely to need intervention when they return the following year, and are more likely to remain on track as they progress through first and second grade and beyond.

Information Technology



What's Due

- **IT Asset Management: Device Summer Storage / Collection** - IT Asset Management would like to ensure that your school is prepared to collect and store your devices before the last day of school, June 7, 2019. The collection of devices assigned to your graduating/matriculating students is especially important, as your school will need these devices (tablets, laptops, chargers, etc.) for new students in the Fall. Here are a few helpful hints:
 - All devices should be checked into Remedy by **May 17, 2019**.

- For a list of students that were assigned a device, follow the instructions on how to generate the student check-out report in the Additional Resources section of the IT Asset Management System Handbook.
- For any graduating and matriculating students, please collect all devices and equipment issued to them prior to leaving the school.
- For students taking their devices home for the summer break, please check in the devices first and re-issue to the same students.
- For any devices not returned, please notify School Police and obtain a Police Report Number. You will need to enter this number in the device status notes section of the IT Asset Management System for lost/stolen devices.
- For any damaged devices, submit a service request ticket. An IT Field Tech will go to your school to see if they will be able to repair these devices.

Please visit the Summer Storage section on the Principal's Portal. This site has guides that are specific to your school, including documentation for the collection and storage of both 1:1 and shared-use devices. A year-end report will be provided to you and your local District Superintendents.

- **Parent Portal/Standardized Testing**

Just a reminder that the **2019 CAASSP** testing results are going paperless and will be available to parents via the Parent Portal. Please encourage parents to sign up on the **Parent Portal** so they can have access to their student test scores. Have your parent community representatives, parent leaders, and staff, share this information at parent workshops, meetings, and events. More information about standardized testing is available on the Office of Parent and Community Services website under Parent Portal (see link below). In addition, as schools are enrolling students for next school year or planning student orientations, please include opportunities for parents to sign up for the Parent Portal. - **Parent Portal/Safety Measure**

Beginning on May 20, 2019, the Parent Portal will be sending out a notification to parents when a student is linked to their account. The Portal will link with MiSiS to pull the phone number and use Blackboard Connect to notify the parent that a student was linked to their Parent Portal account. Blackboard will use the same MiSiS contact file as that used for MiSiS Attendance. Calls will be made seven days a week at around 10:15 AM, and the message is available in English and Spanish. The phone message will say:

“This message is from the Los Angeles Unified School District's Office of Parent and Community Services to inform you that your child, **FIRST_NAME**, was added to your parent portal account this week. If you believe this was done in error, please visit the office at your child's school.”

If a parent comes to the school to report that the Blackboard message was an error, please verify that the information in MiSiS is correct. If the information is not correct, the school should log into the Parent Portal's Employee area and remove the association. The link is:

- **Parent Center**

The Los Angeles Unified School District's Board of Education Resolution (Res-001-17/18) entitled *Learning, Leading and Succeeding for Students* resolved that, on the first day of school, "Parent Centers are up and running with a schedule of Fall Workshops". To ensure workshop topics align with parents' needs and interests, please reach out to the parent leaders of the school for input as part of the planning process for the beginning of the school year.

- **Volunteer Roll Over**

Tier II and Tier III continuing volunteers may be cleared to volunteer by the administrator or administrative designee for the upcoming school year through the Volunteer Management System Roll Over process. The roll over feature will become active in May 2019. Interested Tier II and Tier III volunteers, who would like to continue volunteering at the same school for the upcoming school year, should inform the principal or designee of their interest, then verify, and sign that the contact information previously provided is still up to date. In May or before the end of the school year, the administrator or designee must do the following in the Volunteer Management System to roll over volunteers:

- Document that the volunteer's name has been checked against the California Megan's Law Website.
- Document that the volunteer's TB clearance has not expired.
- Ensure rollover applications are complete and approved online by the administrator or administrative designee.

All volunteer documents (i.e., application, commitment form) must be kept in a secure locked location in the main office for five years. These documents contain personal information regarding volunteers and therefore require a high level of confidentiality and safety.
