- NBCTs have been said to frequently Dazzle others to the core

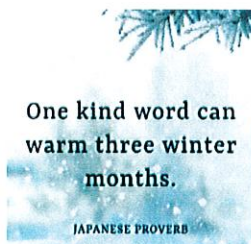

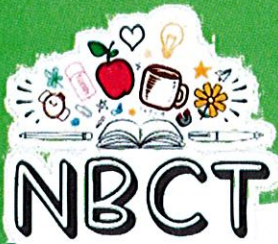

Log Review Update

Fall Log Review is proceeding and each Log has been reviewed. At this point, you should have your Task Log hrs. viewable and should have addressed any comments/emails addressed to you, if, there was an issue that needed your attention. Please take a moment to visit the Tasks you have submitted. Note- the work continues on our end to finalize the details of the submissions. Please alert the reviewer of your Task as soon as possible of any Schoology discrepancies and no later than the 13th of Jan. If a reviewer's name is not apparent you can email Esmerelda. Please expect your payment to be on the Feb. 5th paycheck.

Eligibility for the NBPT Teacher Incentive

The eligibility for the NBPT Teacher Incentive for **NBC Teachers at the Virtual Academies this year** will be determined for each individual Academy based on the criteria determined by the state. Our office is working with them in providing them with the requested information.

Reminder- The incentive is being offered to NBCTs who teach at least 50 percent of a full-time position in high-priority schools for five consecutive years. Award payments are based on the work completed while the NBCT is employed at the local education agency (LEA). Please be aware that the length of a leave may impact your eligibility to receive the incentive.

Fundamentals of Mentoring

The optional 10hr series for next semester's Thursday and Saturday cohort is open for registration.

The opportunity is presented to NBC Mentors who have not taken the Fundamentals of Coaching within 5yrs. Sign up on MYPLN **search:** *Fundamentals of Mentoring* Space is limited.

Mentoring

Is there someone at your school site that you would like to mentor? Do you know if the support you offer is eligible for NBC Mentor hours? Check their credential status on the CTC website.

Then, review the NBC Task 1 Guidelines, found in Schoology. There, you will see if they are eligible under one of Task 1's subsections.

Assigned Mentors for Provisional Teachers are facilitated by Barbara Scott and Mentors for University Interns by Miko Dixon. The list of new teachers is generated each month and Mentors are needed year round.

Once you are assigned, remember to complete the online Mentor Monthly log for your mentee (all except Task 1f and TGI candidates).
