#### **Division of Special Education Update**

## Status on Individualized Education Program (IEP) team meetings

During this global pandemic LAUSD and the Division of Special Education continues its commitment to holding IEP team meetings on time. With the implementation of remote learning assessments and in-person assessments as of November 2020 LAUSD has conducted approximately 26,000 IEP team meetings during the 2020-21 school year. Parents are encouraged to participate virtually and/or via telephone, and if you have any questions on how to do so, please reach out to your child's case carrier or administrator. The District is continuing to send text message reminders to parents regarding scheduled IEP team meetings. ## **December 2 is National Special Education Day**

Beginning in 1971, a U.S. District Court case in the District of Columbia, Mills v. Board of Education, ruled it unlawful to deny exceptional children, including those with mental and learning disabilities, publicly funded educational opportunities. Court cases like this led to the 1975 Education for All Handicapped Children Act which was signed by President Gerald Ford on November 29th. The federal legislation required states that accept federal money to provide equal access to children with disabilities. Additional protections were added in 1986 to support parents and educators in creating an education plan for children with disabilities. In 1990, the Education for All Handicapped Children Act was renamed the Individuals with Disabilities Education Act (IDEA) and improved access for all children with developmental delays. Through the years, the act has been enhanced to improve services and standards throughout the educational system.

### Inclusive Schools Week: December 7-11

Inclusive Schools Week is an annual event organized by the Inclusive Schools Network that celebrates the progress schools have made in providing a supportive and quality education to an increasingly diverse student population, including students with disabilities. The week also provides an important opportunity for educators, students, and parents to discuss what can be done to ensure their schools create and/or enhance a culture that successfully educates all children. The theme for this year's Inclusive Schools Week is "The Time for Inclusion is NOW!"

### **Service Tracking Letters**

For the 2020-21 school year only, the Division of Special Education (DSE) has suspended issuing quarterly letters to parents whose child has received less than 70% of their related service (including Resource) target. The decision to suspend this important communication is due to the impact COVID-19 has had on the reporting structure. The DSE continues to monitor our service tracking performance and consistently communicates with Local District Leadership (i.e. Superintendents, Special Education Administrators) to appropriately address provision of services to students. We will reinstitute this process once normal operations resume.

Parents are encouraged to reach out to their child's case carrier and/or school administrator if they have any questions or concerns.
