### DISTRICT ENGLISH LEARNER ADVISORY COMMITTEE Thursday, May 27, 2021

#### I. Call to Order

Diana Guillen, Chairperson, called the meeting to order at 2:03 pm

#### II. Flag Salute

#### III. Public Comment

#### IV. Visit from the Board of Education Member/Scott Schmerelson, Board District 3

Mr. Schmerelson addressed the membership with a warm greeting and thanked the chair and PCS for their leadership and emphasized that it is an unprecedented year and that despite all the difficulties, they would welcome the staff back to schools. Based on previous dates, the positivity rate was .01%. Very few cases of community transmission have been reported since the schools were reopened. He expressed his gratitude to everyone for getting vaccinated and for continuing in the district's count and protocols so that everyone could be safe and thanked the membership for taking time to participate in all meetings, and their commitment to all their schools and their communities. He also mentioned to them that their involvement is very important, and their leadership is essential to develop this sense of community and for families to continue to be empowered to become involved. Mr. Schmerelson mentioned that he held a mental health webinar aimed at elementary school students as these students were most affected by the pandemic and its transition process. Norma Gonzalez, Secretary conducted the roll call and quorum was established with 32 members at and alternates at 2:56pm.

#### VI. Reading of the Minutes

The May 13, 2021, minutes were read out loud by a member, Ms. Andrea Ambriz. The Chair asked if there was any correction and asked members to make a motion to approve the minutes. Mr.

Armando Cossyleon made the first motion and Ms. Andrea Ambriz seconded. There was not discussion. 27 members voted yes, 1 no. Motion carried.

## **VII. Chairperson Report**

Mrs. Diana Guillen thanked the membership for being present and also members of the public, beginning her report with a phrase **“Negative results are just what I am looking for. **What is the Consolidated Application?**

It is an application submitted online\* to the California Department of Education or CDE and allows the district to apply for federal funds. It also allows the district to report fiscal and program data to CDE.

\*The online system is the Consolidated Application and Reporting System (CARS)

**What is DELAC’s Role with the Con App?  
CA Education Code, Section 64000(d)**

The Consolidated application shall include annual certifications by the school district English learner parent advisory committee...that the application was developed with the review and advice of that committee.

**Application for Funding Page**

In accordance with Title 5 of Section 11308 of the California Code of Regulations, the District English Learner Advisory Committee (DELAC) reviews whether an LEA has more than 50 English learners. The LEA must then establish a District English Learner Advisory Committee which must review and advise on the development of an application to fund programs that serve English Learners.
