|  | <p>The next scheduled revision for the local plan which includes Section B will be during the 2023-24 school year (per 3-year cycle timelines). Sections A (Contacts/Certifications), D (Annual Budget Plan), and E (Annual Services Plan) will be developed/reviewed in Spring 2023 for submission to the Board &amp; CDE by June 30, 2023, as per annual certification/submission requirements.</p> <p><i>“Revisions to the Local Plan Governance and Administration, Section B, must be reviewed by the CAC, county office of education (COE), and must be adopted by each local educational agency’s (LEAs) governing board prior to being submitted to the CDE for review and consideration for approval (EC Section 56195.1). This requirement will not be construed as a prerequisite for submitting changes to the Annual Budget Plan, Section D, or Annual Service Plan, Section E, which are elements of the Local Plan with annual submission requirements.
