IX. **Minutes:**

Introduction to the Local Control Accountability Plan (LCAP) and Local Control Funding Formula (LCFF): Sara Chevallier, LCAP Coordinator, and Chathurika Richier, LCAP Coordinator, explained that the LCAP supports positive academic outcomes, state and local priorities for English learners, low-income students, and foster students.

They discussed Dashboard navigation, A-G requirements for 100% graduation, interventions for AP courses, A-G, Arts Education and Interscholastic Sports, Nursing and Social Workers. They reviewed funding for schools through the Equity Index for Student Needs and the Plan for Student Achievement Student Empowerment Unit Special Education. The 2022-2023 school year LAUSD allocates approximately \$400 million of LCAP funds directly to LAUSD schools through the SENI Student Needs Equity Index. These funds are intended to close achievement gaps for students.

X. **Guidance on Public Data Dashboard:** Sara Chevallier, LCAP Coordinator and Chathurika Richier, LCAP Coordinator, presented projected LCFF-SENI expenditures for 2022-2023.

ThoughtExchange Guidance: Sara Chevallier, LCAP Coordinator and Chathurika Richier, LCAP Coordinator, presented the process for Independent Thought Sharing to better understand strategies for student benefits to drive learning by applying empathy, creativity collaboration to build trust for a better education for a better student focus.

Charlie Sparkle, Parliamentarian, took public comments, there was no public comment.

Overview of the Compensatory Education Plan for Students with Disabilities Affected by Remote Learning during the COVID-19 Pandemic: Diana Massaria, Administrative Coordinator, Division of Special Education, Annmarie Serrano Administrative Coordinator, Division of Instruction spoke about section 504 for Individuals with Disabilities Education IDEA

requires that you have an evaluation based on your disability to get the Special Education services you need, before taking any academic designation action. The 504 Plan Determines how to support making better decisions before carrying out an IEP. Compensation Plan Has More Support for Special Education Students in Schools Section 504 Requires Public School Districts to Provide Free Appropriate Public Education FAPE to all Students with Disabilities in their Jurisdictions. There was a question-and-answer period.
