## Greetings

On behalf of the Los Angeles Unified we express our gratitude and congratulations to the members of the Parent Advisory Committee (PAC) on the drafting of comment for the Local Control and Accountability Plan (LCAP) process. The team at PCS reviewed comments and observe the quality of comments continuing to evolve over time, and especially this year. Your comments spoke about various academic and social emotional topics which continue to highlight the negative impact the pandemic had in the lives of our children. Thank you for your thoughtful attention to writing comments and for the hours you have provided this far as a member of the PAC.

For the month of April our office would like to capture your feedback and thoughts specifically on the Superintendent's 100 Day Plan. Many of you joined the Superintendent on March 25 and provided valuable contributions. The 100 Day Plan will include specific actions for each of the initiatives referenced in the document and become a strategic plan expected to go live toward early summer. One of the items under the "Act" section of the plan is the Family Academy. The Family Academy will be organized into two learning strands and accessible to all families.

- 1. The Family Academy Equity Pathways: Four courses will be offered throughout the year where families will develop community, learn about, and define their role as an empowered leader, rights and responsibilities, and develop an action plan to stay engaged in their child's public education. Families will select from the four equity pathways: for English Learner, Black families, families of children with special needs, and early literary. The curriculum is in development with the Division of Adult and Career Education and by the Multilingual and Multicultural Education Division, Early Childhood Education Division, Division of Special Education, Access Equity and Acceleration, and Black Student Achievement Plan.
- 2. The second strand of the Family Academy will include **course offerings** throughout the year for families at large. We are currently gathering input on the course offerings and themes for the Academy. Superintendent Carvalho has specifically asked to include topics such as Financial Literacy, immigration rights, civic programs and services, mental health and resiliency, school safety and others.
