# I. Call to Order

# VII. Greetings from Board Member

# Monica Garcia Board Member, District 2

He congratulated the parents for their work and input on the PAC committee as we have had a very difficult year with the pandemic. There were 2 questions at the meeting where she referred to the Legislative Office led by Martha Alvarez and her team to support the PAC committee at the

state level. Ms. Garcia emphasized that she has 21 months left on the Board of Education Board 2 and that her fight will continue to ensure that Education Funds are properly used (education) and that the expenses for the crisis of the Covid 19 pandemic are the responsibility of the federal and state government. She received 5 questions in advance which were answered with a general, political, administrative, and narrative aloud.

# VIII. Chairperson's Report:

Chairperson's Report. The hot topic is the reopening of the schools and he hoped that PAC members participated in meetings with their school principal to learn about the guidelines and Plan that LAUSD has developed without consulting parents or listening to their concerns except for parents to fill out a survey to select which system hybrid or continue online. The hybrid system is one where the students will be in a classroom with the assistance of staff supporting problems online because they will be in school, but instruction will continue with teachers online.
