Ms. Martha Alvarez & Ms. Pagter gave an overview of what OGR role and responsibilities are and opened up discussions of Q&A

- Mission of OGR is to ensure the school district & students benefit from legislation, funding & regulations at state and federal levels for the improvement of teaching and learning. OGR's advocacy is aimed at to improve learning environment for all students by gaining greater community support by maintaining continued presence in all decision making processes in all levels of government. OGR's efforts seeks to ensure the enactment of policies and budgets support the priorities identified by the Board and Superintendent to promote student achievement. (www.lausd.

OGR monitors & responds to various education policy and school-related legislative issue areas at state and federal level. They're tracking 500+ bills and waiting to see all bills before they take position for LAUSD's priorities.

Re. LAUSD Legislative priorities determination. OGR brainstorms & seek input during fall (Aug-Oct) & presents to the Board Dec/Jan.. but due to pandemic present in Feb

- -Parent engagement & input essential to making positive improvements to student achievement
