The Parent Advisory Committee and the District English Learner Committee Chairpersons will be preparing for to present their comments the Board of Education at the end of the year, as usual. Our final segment will be on May 26 and will feature how schools may create parent organizations, such as PTA, PTO and booster clubs, as well as forms to complete your group registration and fundraising forms.
