Call to Order/Welcome

Welcome and opening remarks by Antonio Plascencia, Leah Brackins, and Reina Diaz at 10:15 a.m. She/He thanked the parents for coming and introduced the PCS staff.

## PUBLIC COMMENTS

### ROLL CALL/QUORUM at 10:41 am

Members were seated and roll call was conducted by <u>Angie Cardenas, Sr. Parent Facilitator.</u> Quorum was established with <u>40 members present and seated.</u>

### **ELECTION OF PAC OFFICERS**

Leah Brackins, electioneer thanked the outgoing PAC officers and then declared all seats vacant.

### **Chairperson**

The floor was open for nominations for the position of **Chairperson**. 21 votes are needed to win.

The following representatives were nominated or self-nominated:

4.	Paul Robak

The Electioneer asked three (3) times if there are any other nominees, then asked the members to close and accept the list of nominees for the position of **Chairperson** by consensus.

Each nominee was allowed up to 2 minutes to provide a speech. Following the speeches, members voted. Members' votes were tallied. The following results occurred:

The Electioneer asked three (3) times if there are any other nominees, then asked the members to close and accept the list of nominees for the position of **Vice-Chairperson** by consensus.

Each nominee was allowed up to 2 minutes to provide a speech. Following the speeches, members voted. Members' votes were tallied. The following results occurred:
