Academy continues to build great momentum, peaking at 2,000 participants. The schedule with webinar links and information is available at <https://achieve.lausd.net/familyacademy>. This site also includes PowerPoint presentations as well as recorded content. A second segment to this effort includes four courses, with seven classes each, where families will develop community, learn about, and define their roles as an empowered leaders, learn about their rights and responsibilities, and develop an action plan to stay engaged in their child's public education. The four equity pathway courses include one focused on Multilingual Learner excellence, another on Black Student excellence, a third on Special Education excellence, and the fourth on Early Education student excellence. Registration will begin this month.

- **School Site Council and English Learner Advisory Committees:** We are thrilled about the momentum our school sites are building with forming the School Site Council and English Learner Advisory Committees. We worked with each Local District Parent and Community Engagement Team to offer individualized school support to ensure all school sites were forming their councils and committees.
