VI.	Division of Special Education (DSE) Update
	• There's a 98% in person enrollment and 2% online. 8,570 students enrolled in the online program and 1,549 are students with disabilities.
	<ul> <li>From July 1, 2022 to November 30, 2022, approximately 39,395 team meetings have been held.</li> <li>The acceleration days to help children who have had learning loss due to the pandemic were held on December 19 and 20, 2022.</li> </ul>
	<ul> <li>The school experience survey began on October 24, 2022 and will end on December 9, 2022.</li> <li>The District consolidated the 6 Local Districts into 4 Regions; Region North, Region West, Region South and Region East.</li> </ul>
	• Inclusion School's Week was from December 5th to the 9th. This is an annual event where information is provided and is an opportunity for teachers, students and parents to speak about their needs and in this way build capacity to improve the teaching of students. A link was provided for more resources.
	<ul> <li>Flyers were shown regarding parent workshops about the alternative curriculum in 2023. Parents were encouraged to participate. These workshops will be held 2 times per month in 2023 covering different topics.</li> <li>There are two companies that provide homework support to students.</li> </ul>
	<ul> <li>The Parent Portal was also discussed.</li> <li>The Division of Special Education presented their websites and information.</li> </ul>

	GENERAL OVERVIEW OF TRANSITION SERVICES.
	• What are Transition Services?
	Transition Services is a team provided by LAUSD; made up of Administrators, Special Education Teachers,
	Transition Teachers, Parents or Legal Guardians and some agency partners; this team supports students with an IEP in taking the necessary steps to transition from one school to another and to daily life.
	<ul> <li>These Transition Services are provided to students from age 14 and up.</li> </ul>
	<ul> <li>Transition Teachers are in high schools and 8th grade; these teachers support students and teachers so that</li> </ul>
	together they can create an Individual Transition Plan (ITP) that is appropriate for the needs of each student.
	• They give 12th grade students post-secondary resources and prepare them for college. This team is with them
	until the age of 22.
	• When a student is the client of an agency, Transition Teachers invite them to IEP meetings to review the
	Individual Transition Plan (ITP).
	• 12th grade students receive additional support from the Transition Teachers, if the students are not associated
	with any agency, they can be referred to one such as the Regional Center or the Department of Rehabilitation.
	They also support them by visiting local and Community Colleges.
	• They also support them for post-secondary employment by referring them to Bridges to Work. There they help
	them get a job.
	<ul> <li>Another support they provide is how to complete the FAFSA form for financial aid.</li> <li>Mr. Hernández spoke about the Work Based Learning Program.</li> </ul>
	<ul> <li>Work Capacity 1: This is a grant between the California Department of Education (CDC) and LAUSD to</li> </ul>
	provide transition services for students with disabilities.
	• Partnership and Transition Program: This is a contract between the Department of Rehabilitation (DOR) and
	LAUSD that allows us to serve students in all 5 DOR student service areas. These 5 areas are: 1. Job
	Exploration.
	• 2. Work-based learning experience. 3. Post-secondary counseling.
	• 4. Training for repair in a workplace. 5. Training for self defense
	• They provided the website for more resources and support for families.
	• Ms. Nicole Douglas and Mr. David Montalvo, presented Adult Transition Services: The goal of adult transition
	programs is to help students achieve Competitive and Integrated Employment (CIE).
	• They showed a map to see which adult living program, CTC, would be the closest to you.
