Principles of Design (POD)

Key Idea:

Choreographers use the principles of design in crafting and developing their movement phrases and studies.

Dance Forms (or Structures) Key Idea:

Choreographers use dance forms, or structures, to organize their overall works. There are simple dance forms and more complicated structures. Choreographic devices, such as canon and call and response, can be used to organize movement within the overall dance structure.
