

YOUR GUIDE TO FAMILY PREPAREDNESS

#### MAKE A CHILDCARE PLAN

#### > CHOOSE AND ARRANGE YOUR CHILDCARE PLAN IN ADVANCE

- Designate a backup caregiver if you're unable to care for your child. Options include:
  - Verbal agreement: Simple, but not legally binding for decisions.
  - <u>Caregiver's Authorization Affidavit (CAA)</u>: Lets caregiver decide certain school/medical matters; you keep your parental rights.
  - o Guardianship: Court grants custody. Legal advice strongly recommended.
- Discuss plan and roles with family and your designated caregiver.
- Get your child a passport. For U.S.-born child, apply visit: travel.state.gov.

### > TELL SCHOOL/PROGRAMS YOUR BACKUP PLAN IF YOU'RE UNAVAILABLE

- Update emergency contacts; memorize important phone numbers.
- Share medications, allergies, insurance, and legal information with caregiver.

#### YOUR IMMIGRATION OPTIONS

#### > KNOW WHO CAN LEGALLY GIVE IMMIGRATION ADVICE AND REPRESENT YOU

- Use only licensed attorneys verified by the State bar at <a href="www.calbar.ca.gov">www.calbar.ca.gov</a> OR
   Department of Justice (DOJ) accredited representatives on the <a href="Recognized Organizations">Recognized</a>
   <a href="Organizations">Organizations</a> and <a href="Accredited Representatives Roster by State and City">Accredited Representatives Roster by State and City</a>

#### > WHAT TO EXPECT FROM A LEGAL REPRESENTATIVE

- Sign contract detailing services and fees.
- Your legal provider should update you regularly.
- Get free copies of all documents unless otherwise agreed.

#### **KNOW YOUR RIGHTS**

#### > IF ICE IS AT YOUR DOOR:

- Only open the door with judge-signed warrant showing your name.
  - Opening the door means losing some legal rights.
- Use Red Card to assert rights; stay silent with ICE.

#### > INTERACTING WITH ICE:

- Remain silent; do not answer questions.
- Don't share personal or family information.
- Never sign documents without a lawyer present.
- Memorize emergency contacts; you can call if needed.
- Stay calm; don't run from ICE it harms your case.

Where can I get assistance on virtual school options, transportation, immigration, health, wellness and housing?

Los Angeles Unified's Family Hotline: (213) 443-1300 | Accepting calls 24 hours a day, 7 days a week.

#### What are my general rights if I am detained by Immigration and Law Enforcement?

- Do not open the door if an immigration agent is knocking at your home.
- Do not answer any questions you have the right to remain silent.
- Do not sign anything without first speaking to a lawyer.
- You have the right to an attorney, but immigration lawyers are not provided by the government.
- If stopped outside your home, ask: "Am I free to leave?" If they say yes, walk away calmly. 1

#### What should I do to be prepared? Where can I update my emergency contact information?

Preparing a <u>Family Preparedness Plan</u> ensures another adult can care for your child if needed. Update emergency contact information by visiting the school's main office or by using the Parent Portal to update phone numbers. Keeping this information current is essential for emergencies.

#### What documents should I have readily available in case I am detained by ICE?

- Valid work permit or green card if applicable.
- Government-issued ID from the United States (with no reference to status or country of origin).
- Red card to assert your right to remain silent.
- Contact information for someone who can act on your behalf.
- Proof of at least two years of residency in the United States.

## What happens if I am detained in an immigration court? What can a person encounter during deportation proceedings?

If detained, you may be taken to a detention center. Make sure your family has your A-number (if you have one) and your country of origin. They can locate you via the <u>ICE detainee locator</u> online. <sup>1</sup>

#### Where can I find legal representation in immigration court?

- State Bar of California Attorney Search
- California organizations accredited by Board of Immigration Appeals (BIA) to represent immigrants before the Department of Homeland Security (DHS) and <a href="Executive Office of Immigration Review">Executive Office of Immigration Review</a>.
- California Courts Self-Help Centers
- <u>Legal-Aid Offices and Lawyer-Referral Services</u>
- The consulate or embassy of the parent's or guardian's country of origin.

To get a Red Card, please contact your school site and use the following QR code to download a copy in your language of preference.

#### **YOU HAVE CONSTITUTIONAL RIGHTS:**

- DO NOT OPEN THE DOOR if an immigration agent is knocking on the door.
- DO NOT ANSWER ANY QUESTIONS from an immigration agent if they try to talk to you. You have the right to remain silent.
- **DO NOT SIGN ANYTHING** without first speaking to a lawyer. You have the right to speak with a lawyer.
- If you are outside of your home, ask the agent if you are free to leave and if they say yes, leave calmly.
- GIVE THIS CARD TO THE AGENT. If you are inside of your home, show the card through the window or slide it under the door.

I do not wish to speak with you, answer your questions, or sign or hand you any documents based on my 5th Amendment rights under the United States Constitution. I do not give you permission to enter my home based on my 4th Amendment rights under the United States Constitution unless you have a warrant to enter, signed by a judge or magistrate with my name on it that you slide under the door. I do not give you permission to search any of my belongings based on my 4th Amendment rights. I choose to exercise my constitutional rights.

These cards are available to citizens and noncitizens alike.
