PURPOSE: The purpose of this Memorandum is to collect W-9 information from

schools regarding payments made from student body funds to

independent contractors and/or organizations during the 2025 calendar

year (January 1–December 31).

These payments may include services such as:

- Entertainment (e.g., DJ, Performer, Magic Show, Band, etc.)
- Decorations (e.g., Balloons, Flowers, etc.)
- Campus beautification (e.g. Mural, Landscaping, Marquee, etc.)
- Other services provided by individuals, sole proprietors, partnerships, or LLCs

Because all student bodies share the same federal taxpayer identification number, this data is needed to centrally determine which payments meet the IRS reporting requirements and if the individual or organization needs to be issued a 1099-NEC.

MAJOR CHANGES: This Memorandum replaces MEM-103900.3 dated November 18, 2024. and includes the following major updates:

- Attachment A has been converted to a digital format.
- Schools must now use the Microsoft Forms version of <u>Attachment</u>
 <u>A</u> instead of submitting the paper form.

GUIDELINES: To complete this report, you will need the following documents:

• 2024-25 Student Body Ledgers (January-June)

• 2025-26 Student Body Ledgers (July-December)

• W-9 forms of the Independent Contractors

Once you have gathered these documents, review each ledger for each month to identify individuals or organizations that were paid for services rendered during this period.

Once all individuals and organizations that received payments have been identified, locate their corresponding W-9 forms and complete Attachment A using the Microsoft Forms link provided.

Important: You must complete a separate <u>Attachment A</u> for each individual and/or organization that received payment regardless of the payment amount.
