
The Los Angeles Unified School District is committed to achieving equity in college readiness, access, and enrollment for all students. The importance of applying for the Free Application for Federal Student Aid (FAFSA) or the California Dream Act Application (CADAA) aligns to the 2022-2026 Strategic plan to ensure that all students graduate college and are career ready and is nationally recognized as a critical step on the path to college.

In 2022-2023, over 96% of Los Angeles Unified students submitted a FAFSA/CADAA application, and 89% of students fully completed the application last year. Out of the 64% of students eligible for a Cal Grant, 53% were awarded a grant.

In addition to the District goal of 100% completion, California passed AB469 (2021), amended California Education Code Section 51225.7 so that, beginning with the Class of 2023, each grade 12 student will need to complete a FAFSA or CADAA application unless the student or family elects to opt-out.

We are excited to share our **Financial Aid Success Toolkit (FAST)** to support efforts to help our students and families complete their financial aid applications. FAST includes a guide for schools with engagement strategies to support financial aid completion. There are videos, slide decks, communication templates, and social media samples to communicate effectively with students and families about important deadlines as well as opportunities to get support in completing their applications.

New for 2024-2025: **Better FAFSA/ Better CADAA**

FAFSA Overview

- An FSA ID is an account username and password that is required to access the FAFSA form. Users without a Social Security number can create an FSA ID to access the FAFSA form.
 - Need FSA ID to access and edit information online
 - Two-step verification for everyone setting up the FSA ID
- **FAFSA roles:**
 - Roles: Student (applicant), Parent (contributor)
 - Once all required fields have been provided and all sections have been signed, any role can submit the FAFSA form
 - Dependent students must invite their parent(s) to contribute to their form if parent information is required
 - Independent students and a dependent student's parent must invite their spouse to contribute to the student's form, if spouse information is required
- **Contributors:**
 - Possible contributors: Parent, Other Parent, Student Spouse, and Student (when invited by Parent)
 - Contributors must provide the required information and sign their respective section on the FAFSA form to be considered complete
- Requires consent from contributors to:
 - Retrieve and disclose federal tax information
 - Be eligible for federal student aid
 - Be eligible to receive an SAI (Student Aid Index) formerly EFC (Expected Family Contribution)
- Eligibility for need-based financial aid is determined by subtracting the student's SAI and other financial assistance from the cost of attending school.
 - Equation: Cost of Attendance (COA) Student Aid Index (SAI) Other Financial Assistance (OFA) = Financial need

New for 2024-2025: **Better FAFSA/ Better CADAA**

2024-2025 FAFSA Updates

- Students can list up to 20 colleges (previous limit was 10)
- Online FAFSA available in 11 most common languages spoken in U.S.
- Paid preparation no longer permitted
- More financial aid for single parent households. Two types:
 - Dependent students with just one parent
 - Independent students who are single parents
- Greater eligibility for the maximum Federal Pell Grant
- Less aid for middle-income and high-income families
- Less aid for families with multiple children in college
 - Household size is now Family size and will be determined by the number of exemptions claimed on the federal tax return
 - Can modify the family size to reflect current number



New for 2024-2025: Better FAFSA/ Better CADAA


2024-2025 FAFSA Updates

- New questions on student's gender, race, and ethnicity (no effect on student aid eligibility)
- 2 Changes to Reportable Income:
 - Types of untaxed income no longer reported (cash support, money paid on student's behalf, Veteran's education benefits, Workman's Compensation)
 - Gifts to students such as distributions from 529 college savings plans owner by a non-custodial parent or grandparent no longer affect aid eligibility
 - Child support received is now reported as an asset instead of income
- 3 Changes to Reportable Assets:
 - All assets are considered in the formula. Small businesses and farms are no longer excluded
 - Simplified Needs Test is now known as "Applicants Exempt from Asset Reporting"
- 4 Income is reported for the parent who provides the most support
- 5 Student Aid Index (SAI) can have a minimum of -\$1500
 - A negative value does NOT increase Federeal and State aid, but may increase institutional aid
- 7 Identity match required for each contributor to verify FSA ID
 - A unique verified email address will be required to establish an account
 - Family members cannot use the same account
- 8 Users can apply for an FSA ID without entering an SSN or ITIN
 - Users without an SSN or ITIN will need to complete a knowledge-based identity verification process

FAFSA/CADAA Talking Points

General Talking Points:

- Students who file a FAFSA/CADAA have better postsecondary outcomes they enroll directly into college in higher numbers, persist in college longer, and complete a bachelor's degree at higher rates than non-filers.
- In addition, students who complete and submit their financial aid applications become eligible for a greater number of funding sources for college: federal student loans with lower interest rates, forgivable student loans, federal and state scholarships and grants, and institutional aid.
- Los Angeles Unified is dedicated to finding creative solutions to support students in completing FAFSA/ CADAA applications. We are providing schools with additional funding to offer after school and weekend help for students to complete their financial aid applications. As students complete their applications, schools will shift to supporting understanding financial aid award letters, tuition bills and payment options, the verification process, scholarship/grants search and loan options, college acceptance decisions, and submitting the Statement of Intent to Register.
- Los Angeles Unified is working closely with our community partners at L.A. Cash for College and CAL-SOAP to offer workshops for families and students. Topics range from financial literacy, financial aid overviews, to hands-on completion of the FAFSA/CADAA. Workshops are offered live and recorded for on demand viewing, in both English and Spanish. Future workshops will include how to read financial aid award letters, discussing the best match and fit as our graduates begin to make decisions for transition.



FAFSA/CADAA Talking Points

For students and families:

- Did you know that 2/3 of jobs now require some college education? Whether you already have your sights set on college, or if you're still exploring your options after graduation, all seniors should apply for financial aid by the Priority deadline of April 2, 2024.
- Don't miss your opportunity to get FREE money to pay for the education you need for a successful career. Getting an Associate's Degree will help you earn an extra \$7,000 a year on average than with just your high school diploma.
- All Los Angeles Unified graduates can go to college for FREE at any of the L.A. Community College District's 9 campuses through the L.A. College Promise Program. But you have to apply for financial aid by the Priority deadline of April 2, 2024.
- Each year, hundreds of billions of dollars in financial aid are awarded nationally to undergraduate students in the form of grants and scholarships, work-study, and loans. Financial aid is provided by the federal government, the state governments, and colleges and universities.
- Interested in financial aid? You'll need to complete the FAFSA this year! You will need an FSA ID, so create one as soon as possible as it can take up to three days before you can use your account. FSA ID is a username and password combination used to log in, complete, and submit the 2024-2025 FAFSA form. You can find more information on getting an FSA ID at the Federal Student Aid Website
- FAFSA and CADAA are due by the Priority deadline of April 2, 2024 to qualify for aid. If you make a mistake on your form, you will need your FSA ID to make corrections. Corrections can also be made after the Priority deadline of April 2, 2024.
- You can correct a mistake after April 2, but you need to submit by the deadline.

Reach out to the financial aid office of the college you plan to attend if there will be a significant change
in you or your parent's income for the present year or if your family has other circumstances that cannot
be reported as the FASCA forms.




- Educators, did you know that you can access support for helping students complete financial aid applications? Direct students to resources and financial aid workshops offered by L.A. Cash for College, CAL-SOAP and CSAC.
- Many students do not complete financial aid applications for several reasons: financial aid applications are complicated; parents may feel uncertain about sending their children to college, especially if they rely on them for childcare or for income support; students may feel unsure about going to college, worried about leaving their families, or that they won't belong.
- Educators can help in promoting a sense of urgency with your seniors with financial aid applications. Share the importance of financial aid and post-secondary education and coordinate with your school counselors to offer assistance and resources to help students complete their financial aid applications by the Priority deadline of April 2, 2024.




The Why of Financial Aid

Financial Aid Basics

Why do I need to provide all the private information requested on the applications? How is this information shared?

The information you provide on your college financial aid applications is used SOLELY for determining financial aid. It is shared only with the financial aid office and no other government entities.

Why should I complete a financial aid application if I'm not applying to college this fall?

Even if you don't think you will attend college, it is important to apply for financial aid before the Priority deadline of April 2, 2024. You don't HAVE to accept the aid, but you can't ask for it later.

Who is eligible for the FAFSA? What is the deadline?

All students who are U.S. citizens, U.S. permanent residents, or other eligible non-citizens who will graduate from high school or have received their GED. All students who are eligible should apply by the Priority deadline of April 2, 2024. But students shouldn't wait until the last minute. Some colleges use FAFSA as a starting point for determining how much financial support a student will need, so the earlier a student can submit their FAFSA, the earlier they can work with their college to determine other financial aid supports that might be available to them.

Who is eligible for the CA DREAM Act? What is the deadline?

The California Dream Act allows undocumented and nonresident students who qualify for a non-resident exemption under Assembly Bill 540 (AB 540) to receive certain types of financial aid such as: private scholarships funded through public universities, state administered financial aid, university grants, community college fee waivers, and Cal Grants.

Students who live in California and meet the eligibility requirements for a non-resident exemption, as well as students who have a U Visa or TPS status, can use the California Dream Act Application (CADAA). Similarly, students without Social Security Numbers or students who have lost DACA status (or never applied for DACA), may still be eligible. Students are encouraged to apply by the April 2 Priority deadline to ensure they are considered for all financial aid for which they might be eligible.

What is a CAL Grant and how do I apply?

The Cal Grant is a California-specific financial aid allocation that does not need to be paid back. Cal Grant applicants who apply for the FAFSA or CADAA by the deadline and meet all eligibility, financial, and minimum GPA requirements of either program automatically receive a Cal Grant. Grants are for students attending University of California, California State University, California Community College, or qualifying independent and career colleges or technical schools in California.

Supporting Foster Youth and Students Experiencing Homelessness

What is the CHAFEE grant and who is eligible to receive it?

The California Chafee Grant for Foster Youth (Chafee Grant) awards up to \$5,000 a year to eligible foster youth to be used at any eligible career or technical training school, California college or university. You can also attend schools in other states. To be eligible, students must meet the following eligibility criteria:

- 1. Not have reached your 26th birthday as of July 1st of the award year.
- 2. If you were in foster care for at least one day, between the ages of 16 and 18.

 Be a youth who was placed in out-of-home care by a tribe or tribal organization between the ages of 16-18.

Resources Designed for Undocumented Students

What happens if a student is eligible for the FAFSA but their parents are undocumented?

Your parent or spouse doesn't need an SSN to complete their section of your FAFSA form.

Starting in December 2023, parents or spouses will be able to create a StudentAid.gov account without having an SSN to access their portion of your FAFSA form. On the 2024–25 FAFSA form, if the parent or spouse is completing their own section and doesn't have an SSN, the SSN will be blank and disabled. If the parent or spouse has an Individual Taxpayer Identification Number (ITIN), they should add it to the FAFSA form. If they don't have an ITIN, they should leave that question blank.

Note: The StudentAid.gov account your parent creates for the 2024–25 FAFSA form can't be used for the 2023–24 FAFSA form.

On the 2023–24 FAFSA form, if your parent doesn't have an SSN, your parent must enter 000-00-0000 when the FAFSA form asks for their SSN. You'll have to print out the signature page from the online FAFSA form so your parent can sign it and mail it to the address indicated.

How can immigrant students who are documented or undocumented get support to navigate college financial aid?

Immigrants (documented and undocumented) often have a harder time finding the supports they need to access financial aid for college. High schools that make a concerted effort to train staff in the financial aid application process and support immigrant students can make a big difference. Community based organizations such as **Immigrants Rising**, A College Bridge Cafe, and Latino U College Access can provide additional expert support.

What documents do students and their families need to complete the FAFSA?

All students and contributors identified must obtain a Federal Student Aid ID (FSA ID) to sign the FAFSA electronically — there should be one ID for the student and separate ID is for the parent/ other contributors — prior to completing their FAFSA. It takes only a few minutes. Students with parents who are undocumented can still file the FAFSA. While parents who are undocumented are not able to use a SSN, they can obtain an FSA ID and provide consent. They can print the signature page, complete it, and mail it in instead.



What Happens after Submitting?

What are verification requests?

It is common for students and families to be asked to submit copies of documents (generally income tax returns, W-2 forms, and 1099 forms) to help financial aid administrators certify that all the information submitted on the FAFSA/CADAA form is accurate. If families receive an email notice, phone call or letter from a FAFSA/CADAA administrator or college with a verification request, they should respond as quickly as possible with the requested information. The colleges' financial aid office will keep this information confidential. Students and families should reach out to their school for support if you receive verification requests. Verification requests are not unusual, and schools can help navigate how to respond promptly.

Will I have to complete financial aid forms every year?

Yes. You must submit forms every year you are enrolled in college, and the earlier you do so the better. Usually the FAFSA and CADAA application windows open October 1 each year.

Are there any good resources online where I can get my questions answered or get additional support about financial aid?

Yes! If you've been accepted by any college or university, the school's financial aid representatives are a great resource. They are experts in financial aid for college whom you can meet with individually. In addition, many colleges and universities host admitted students events where you can also get financial aid support.

What happens after I submit my FAFSA/CADAA?

All students should create a WebGrants 4 Students (WG4S) account to monitor and manage their state awarded financial aid. After a student's FAFSA or CADAA application is processed, they will receive an email from CSAC letting them know it's time to create their WebGrants 4 Students account. WebGrants 4 Students (WG4S) will let students check the status of their state grants, and take necessary steps to secure their aid. It's important to note that a student's WG4S account does not replace their school or FAFSA accounts and they may need more than one account to successfully apply for financial aid. Stay up-to-date on deadlines and requirements by reading all correspondence from CSAC, FAFSA and your school of attendance.

Where can I go to apply for more aid - like scholarships?

FAFSA/CADAA and the CA Community College Promise

What is the L.A. College Promise? How do I apply and what are the benefits?

The Los Angeles College Promise (LACP) serves first-time, full-time college students and is designed to support students to complete a higher education degree and/or a workforce certificate. LACP helps students "start right" on their way to "ending right" with a degree, university transfer or workforce certificate in a timely, efficient manner. It is a partnership between Los Angeles Community College District (LACCD), Los Angeles Unified School District (LAUSD), City of Los Angeles, L.A. Chamber of Commerce, UNITE L.A. and private philanthropy.

Important aspects of the Promise are waived tuition for the first two years of college, priority enrollment, the opportunity to receive a free laptop, additional financial support, and a dedicated support team providing academic and student support services.


FAFSA/CADAA Resource Bank of **Engagement Activities**



To help message the value of FAFSA/CADAA, and flyers and infographics are provided, along with templates for holding events to support FAFSA/ CADAA workshops. Many are in English and Spanish.



Keep in contact with families – use Blackboard Connect (phone and text), Schoology, website, emails, and social media to families with reminders about the FAFSA/CADAA as well as information about upcoming deadlines, school counselor office hours and opportunities to get support to complete financial aid applications.



Regularly check on your school's progress toward FAFSA/CADAA completion. The only way to access individual student completion is to have a Webgrants Administrator. This person is assigned by the principal and has access to updated financial aid completion used to track how well your school's efforts are working and target resources to individual students and families who need support.



Make FAFSA/CADAA a team effort and involve families and school staff. At every meeting with families, add in a few slides sharing the importance of the FAFSA/CADAA. Use professional development time to share instructional videos with staff to increase awareness of the FAFSA/ CADAA. These videos will address specifics on supporting students who file the FAFSA and those who file the CADAA navigate to the college

financial aid application process.





Race to Submit

Regularly check on your school's progress toward FAFSA/CADAA completion. The only way to access individual student completion is to have a Webgrants Administrator. This person is assigned by the principal and has access to updated financial aid completion used to track how well your school's efforts are working and target resources to individual students and families who need support.

Financial Aid Awareness
