Safe School Plan, Volume 1 — Prevention Programs Due!

The following are tips for administrators to help you complete your Safe School Plan (SSP), Volume 1 - Prevention Programs.

- The SSP, Volume 1 update was due March 1. If you haven't already done so, send a hard copy to your district's Local District Operations Coordinator.
- The checklist of items to include is on pages 2-7 of the plan and should be stapled to the top of the updated packet.
- Update Chapter 2 only, with two goals each for the sections on *People and Programs* and *Physical Environment*.
- Only high schools and middle schools are required to include Safe School Zone Maps (SSZM) with their updates. SSZMs must show where Safe School Zone signs are posted on and around your site. For information about SSZMs, contact Alice Gualpa at (213) 241-2523, or by email at <u>alice.gualpa@lausd.net</u>.
- Chapter 8 should be used as a guide for developing discipline and attendance policies that are consistent with LAUSD policies. The Board adopted an updated discipline policy at its meeting on February 27.

Warning on Exposure to Bodily Fluids

If you come into contact with the bodily fluids of another person, the first thing to do is to use utmost care to protect yourself and those around you from contracting bloodborne pathogens from the fluids. **Treat all such fluids as if they are contaminated with bloodborne pathogens**, even if the person who has secreted the fluid looks healthy.

• What are bloodborne pathogens?

Bloodborne pathogens are small organisms including viruses and bacteria that are present in human blood and can cause disease in humans. The viruses that cause AIDS, hepatitis B and hepatitis C are examples of bloodborne pathogens.

• How can I be exposed?

Bloodborne pathogens can be passed to you if blood or certain bodily fluids from an infected individual get into your mucous membranes (eyes, nose, mouth), or directly into the bloodstream through skin that is damaged (e.g., scraped, cut) or punctured (e.g., needle stick injury).

• What can I do to protect myself?

If you are at risk of contracting bloodborne pathogens, you will receive training from District Nursing Services to learn how to protect yourself from exposure. Some of these protective measures include wearing disposable gloves, washing hands properly, and maintaining clean work surfaces. You will also be offered a vaccination series, which will decrease your susceptibility to hepatitis B infection if you are exposed to the virus.

• How can I tell if someone is infectious?

You can't! Many people infected with bloodborne pathogens don't even know they are infected. Treat all human blood and some body fluids as if they are contaminated with bloodborne pathogens.

• What happens if I'm exposed?

If blood or other potentially infectious materials contact your skin or clothing or enter mucous membranes, wash the exposed area gently but thoroughly or remove your soiled clothing. Report exposure immediately to your supervisor and the school nurse. You will receive a medical evaluation by a qualified healthcare professional to determine if there is any possibility of infection. You will be given treatment and information about your risks of infection.
