## **RESOLUTION 2014-02**

# A RESOLUTION OF THE SCHOOL CONSTRUCTION BOND CITIZENS' OVERSIGHT COMMITTEE REGARDING RENEWAL OF OVERSIGHT CONSULTANT CONTRACT FOR **FISCAL YEAR 2014-2015**

WHEREAS, Thomas A. Rubin ("Oversight Consultant") has served as the Oversight Consultant to the School Construction Bond Citizens' Oversight Committee ("BOC") since June of 2001; and

WHEREAS, the current contract for the Oversight Consultant will expire on June 30, 2014; and

WHEREAS, the BOC will continue to require the services of the Oversight Consultant for fiscal year 2014/2015, and desires that the Oversight Consultant be formally engaged to provide such services; and

WHEREAS, in light of the fiscal status of the Los Angeles Unified School District during the 2013-2014 fiscal year the Oversight Consultant agrees to remain at his previous annual billing of 1,000 hours not to exceed \$169,000.00 annually for the proposed term of the renewed contract for 2014/2015; and

WHEREAS, the BOC has reviewed the conceptual terms of the proposed contract for the Oversight Consultant for fiscal year 2014/2015; and

WHEREAS, the BOC believes it is essential that the Oversight Consultant's contract be renewed and executed prior to the June 30, 2014 expiration date to ensure the continuity of services to the BOC.

## NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The BOC desires that no changes be made to the contract terms in the current contract for Oversight Consultant services, except for the period of the contract as identified above.
- 2. It is the intention and desire of the BOC to have this contract prepared in time for it to be presented to the Board of Education no later than its first meeting in May 2014, when it is anticipated that the contract extensions for Facilities Services Division Construction Management contracts will be considered and fully executed and operative prior to July1, 2014.
