WHEREAS, District Staff proposes that the Board of Education approve an amendment to the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to approve energy efficient lighting upgrades at school sites throughout the District (potential sites are listed in Attachment A) for a total budget of \$30 Million (collectively, the "Project") as described in Board Report 377-14/15 attached hereto; and

WHEREAS, the District's current electricity budget to operate all its facilities is \$94.6 Million, and approximately 30 percent of the overall consumption is attributed to lighting; and

WHEREAS, the District's legacy school sites contain 625,000 light fixtures, many of which are deteriorated, inefficient and may pose health and safety concerns (Legacy school refers to schools constructed prior to the District's current Bond Program); and

WHEREAS, outdated inefficient lighting systems are known to consume 35 to 55 percent more electricity than modern, efficient lighting systems; and

WHEREAS, it is important that the District continues to address schools' significantly outdated and inefficient lighting systems; and

WHEREAS, modernizing antiquated lighting systems that are well beyond their useful life will provide students and teachers with an enhanced learning environment that is safe, and promotes productivity and learning; and

WHEREAS, newer lighting systems are more efficient to operate, which will further reduce the impact on the General Fund and the environment; and

WHEREAS, staff's proposal will focus on upgrading T-12 lighting systems containing magnetic fluorescent lighting ballasts manufactured prior to 1980 that may contain organic chemicals such as polychlorinated biphenyls (PCBs), and certain T-8 lighting fixtures that have been known to catch on fire after extended use; and

WHEREAS, the removal and upgrade of all lighting systems will be coordinated with the District's Office of Environmental Health and Safety, and will be executed in accordance with all relevant District, Local, State and Federal Government guidelines; and

WHEREAS, this effort will result in the Districtwide elimination of light fixtures containing PCBs, and an anticipated avoidance of \$1 Million in General Fund costs annually; and

WHEREAS surveys of the lamps/fixtures at the school sites listed on Attachment A will be conducted to identify lighting fixtures that are inefficient, deteriorated and potentially unsafe; and

WHEREAS, the surveys will result in a list of school sites expected to receive a complete lighting upgrade, prioritized based on the condition of lighting systems and grade configuration; and

WHEREAS, staff's approach will be to start with the schools serving the District's youngest students first; and

WHEREAS, inefficient and failing lamps/fixtures will be replaced at as many school sites as the \$30 Million funding allocation permits; and

WHEREAS, the Facilities Services Division will report on progress of this effort in the annual update to the FSD-SEP; and

WHEREAS, these upgrades are anticipated to begin survey and construction in Q2-2015 and be completed in Q4 2018; and

WHEREAS, if this item is approved, \$30 Million in Bond program funds earmarked specifically for critical school repair and safety improvements to school building components will be allocated to lighting upgrades at schools throughout the District; and

WHEREAS, it's anticipated that the District will avoid \$1 Million in annual General Fund costs for electricity once the lighting upgrades are completed; and

WHEREAS, these actions are consistent with the District's commitment to address unmet school facilities needs and provide students with a safe and healthy learning environment; and

WHEREAS, District Staff has concluded that the proposed SEP amendment will facilitate implementation of the FSD SEP, and therefore, it will not adversely affect the District's ability to successfully complete the FSD SEP.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The School Construction Citizens' Bond Oversight Committee recommends that the Board of Education adopt an amendment to the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to approve energy efficient Lighting Upgrades at school sites throughout the District (potential sites are listed in Attachment A) for a total budget of \$30 Million (collectively, the "Project") as described in Board Report 377-14/15 attached hereto in the form it was presented to the BOC and is incorporated herein by reference.
2. This resolution shall be transmitted to the Los Angeles Unified School District Board of Education and posted on the Oversight Committee's website.
3. The District is directed to track the above recommendation and to report on the adoption, rejection, or pending status of the recommendations as provided in section 6.2 of the Charter and Memorandum of Understanding between the Oversight Committee and the District.

BOARD REPORT

Action Proposed: Staff proposes that the Board of Education approve an amendment to the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to approve \$30 Million of energy efficient lighting upgrades at school sites throughout the District (potential sites are listed in Attachment A). Construction is anticipated to start in the first quarter of 2015, and be completed in the fourth quarter of 2018.

Background: The District's current electricity budget to operate all its facilities is \$94.6 Million, and approximately 30 percent of the overall consumption is attributed to lighting. The District's legacy school sites contain 625,000 light fixtures, many of which are deteriorated, inefficient and may pose health and safety concerns (Legacy school refers to schools constructed prior to the District's current Bond Program). Outdated inefficient lighting systems are known to consume 35 to 55 percent more electricity than modern, efficient lighting systems. As such, it is important that the District continues to address schools' significantly outdated and inefficient lighting systems.

Modernizing antiquated lighting systems that are well beyond their useful life will provide students and teachers with an enhanced learning environment that is safe, and promotes productivity and learning. Additionally, newer lighting systems are more efficient to operate, which will further reduce the impact on the General Fund and the environment.

Staff's proposal will focus on upgrading T-12 lighting systems containing magnetic fluorescent lighting ballasts manufactured prior to 1980 that may contain organic chemicals such as polychlorinated biphenyls (PCBs), and certain T-8 lighting fixtures that have been known to catch on fire after extended use. Safety, and will be executed in accordance with all relevant District, Local, State and Federal Government guidelines. This effort will result in the Districtwide elimination of light fixtures containing PCBs, and an anticipated avoidance of \$1 Million in General Fund costs annually.

Expected Outcomes: If the Board of Education approves staff's proposal, surveys of the lamps/fixtures at the school sites listed on Attachment A will be conducted to identify lighting fixtures that are inefficient, deteriorated and potentially unsafe. The surveys will result in a list of school sites expected to receive a complete lighting upgrade, prioritized based on the condition of lighting systems and grade configuration. Staff's approach will be to start with the schools serving the District's youngest students first. Inefficient and failing lamps/fixtures will be replaced at as many school sites as the \$30 Million funding allocation permits. The Facilities Services Division will report on progress of this effort in the annual update to the FSD-SEP.

Board Options and Consequences: A "yes" vote will allow staff to move forward with \$30 Million of energy efficient lighting upgrades at schools Districtwide. Modernizing antiquated lighting systems that are well beyond their useful life will provide our students and teachers with an enhanced learning environment that is safe, and promotes productivity and learning. Additionally, the newer lighting systems will further reduce the impact on the General Fund by avoiding an anticipated \$1 Million annually in electricity costs.

If the proposed action is not approved, District school sites will continue to operate with deteriorated and inefficient lighting systems that may pose health and safety concerns. Additionally, inefficient lighting systems consume approximately 35 to 55 percent more electricity than upgraded energy efficient lighting systems. If the proposed upgrades are not executed, the District's electricity consumption will not be decreased and the anticipated annual General Fund cost avoidance will not be realized.

Policy Implications: This proposed action is consistent with the District's commitment to address unmet school facilities needs and provide students with a safe and healthy learning environment.

Budget Impact: If this item is approved, \$30 Million in Bond Program funds earmarked specifically for critical school repair and safety improvements will be allocated to undertake energy efficient lighting upgrades at schools throughout the District. It's anticipated that the District will avoid \$1 Million in annual General Fund costs for electricity once the lighting upgrades are completed.

Issues and Analysis: Staff has been methodically working to improve the lighting conditions in the District's legacy schools. As a matter of ongoing maintenance, broken light fixtures are replaced with new light fixtures on a regular basis. Additionally, with the support of a Direct Install Program with the Los Angeles Department of Water and Power (LADWP), and \$6 Million of energy conservation lighting upgrades funded with Bond Program funds, more than 26,000 fixtures have been upgraded to date. Furthermore, a new Memorandum of Understanding with the LADWP will commit up-to \$16.7 Million annually for a three-year period toward our energy and water efficiency efforts. It is anticipated that an additional \$200 Million would be needed to address all antiquated lighting systems in schools Districtwide. Staff currently anticipates that an additional \$200 Million investment would enable the District to avoid \$7 Million annually in General Fund costs.

Bond Oversight Committee Recommendations: This item was considered by the School Construction Bond Citizens' Oversight Committee ("BOC") at its meeting on February 26, 2015. Staff has concluded that the proposed amendment to the FSD-SEP will help facilitate implementation of the SEP, and therefore, it will not adversely affect the District's ability to successfully complete the SEP.
