# APPROVAL OF THE 2017 INFORMATION TECHNOLOGY DIVISION STRATEGIC EXECUTION PLAN

February 14, 2017 Information Technology Division

#### **Action Proposed:**

ITD is requesting Board of Education approval for the Information Technology Division (ITD) Strategic Execution Plan (SEP) dated February 2017. This SEP is an update to the 2015 ITD SEP. ITD is requesting Board approval for program updates - actions on programs that were previously approved by the Citizens' Bond Oversight Committee (BOC) and Board of Education (BOE).

Program Updates within the February 2017 ITD SEP include:

- Classroom Technology Modernization Program
  - Instructional Technology Initiative Budget increased by \$4,000,000, approved April 12, 2016 (BOE 363-15/16)
- School Network Modernization Program
  - Local Area Network Modernization
  - o IT Network Equipment Upgrades New projects with total budget of \$7,163,589 (\$2.90 million in repurposed savings from completed projects and \$4.26 million in potential E-rate discounts that have not yet been received), approved October 18, 2016 (BOE 168-16/17)
  - o Core Network Modernization
- Safety, Communications and Security Modernization Program
  - o Radio Systems Program
- Student Information Systems Optimization Program
  - My Integrated Student Information System Budget increased by \$40,300,000, approved April 12, 2016 (BOE 320-15/16)
- Cafeteria Management System Point of Sale Technology Upgrade Project New project with budget of \$4,300,000, approved May 10, 2016 (BOE 406-15/16)
- Disaster Recovery and Business Continuity Program
  - Disaster Recovery and Business Continuity Project

The total increase in the IT SEP budget due to the previously approved actions is \$48.6 million. The adjusted budget is \$837,134,171.

Project updates will be provided on a quarterly basis or as requested.

#### Background:

Approved by the BOE in November 2015, the ITD SEP is the roadmap LAUSD uses to deliver an optimized information, safety and communications infrastructure to support a high performance learning environment in the 21st century. In alignment with this vision, the BOE allocated funds in 2015 and 2016 to facilitate new

projects and approved updates and new actions for continuing projects. The 2017 IT SEP provides status updates for all projects previously authorized by the Citizens' Bond Oversight Committee (BOC) and BOE.

Approval of the 2017 ITD SEP will allow for the continuation of the programs listed above. The SEP includes program budgets, scopes, schedules and status updates for projects funded through bond, E-Rate, and/or General Fund and a list of projects scheduled for future execution.

## **Expected Outcomes**:

Board approval of the 2017 Information Technology Division Strategic Execution Plan.

#### **Board Options and Consequences:**

A "Yes" vote supports the development of 21st century learning environments in the classrooms of LAUSD by approving the continuation of SEP programs.

A "No" vote would delay projects, impact current contracts, and impact potential E-Rate funding.

#### **Policy Implications:**

This action has been reviewed and does not change District policy.

### **Budget Impact**:

Budget increases associated with the 2017 ITD SEP in the amount of \$48.6 million were previously approved (see Action Proposed section above).

The actions within the 2017 ITD SEP are funded by Local Bond Measures K, R, and Y, the Federal E-Rate program, and General Fund. The School Network Modernization projects that are in planning are partially bond funded for match and applications for E-rate funding will be filed.

#### **Issues and Analysis:**

This item was considered by the School Construction Bond Citizens' Oversight Committee (BOC) at its February 2, 2017 meeting. Staff has concluded that this proposed SEP amendment will facilitate the implementation of the ITD SEP, and therefore it will not adversely affect the District's ability to successfully complete the ITD SEP.
