WHEREAS, District Staff proposes that the Board of Education approve an amendment to the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to define and approve a program to provide automated fire alarm dialer systems at 155 sites with a combined budget of \$2,952,750 as described in Board Report 536-16/17 attached hereto; and

WHEREAS, on January 14, 2014, the Board of Education approved the establishment of the School Upgrade Program (SUP), the next phase of the District's Bond Program which will modernize, build and repair school facilities to improve student health, safety and educational quality; and

WHEREAS, the SUP includes a spending target to address "Critical School Repair and Safety Improvements to School Building Components"; and

WHEREAS, District Staff has determined that the Program is necessary to improve student health, safety and educational quality; and

WHEREAS, the Board of Education's approval of the Program will authorize District Staff to proceed with the expenditure of bond funds to undertake the Program in accordance with the provisions set forth in Measures K, R, Y and Q; and

WHEREAS, this program is consistent with the District's commitment to address unmet school facilities needs and provide students with a safe and healthy learning environment; and

WHEREAS, the program will provide an automated fire alarm dialer system which includes a central monitoring station account; and

WHEREAS, connection to a central monitoring system is necessary to bring sites into compliance with District safety standards and to provide timely and reliable dispatch of emergency response personnel in the event of a fire at the site; and

WHEREAS, the installation of required infrastructure and additional phone lines will provide direct contact with the central monitoring system and ensure the safety of school occupants and their facilities; and

WHEREAS, District Staff has concluded that the proposed SEP amendment will facilitate implementation of the FSD SEP, and therefore, it will not adversely affect the District's ability to successfully complete the FSD SEP.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The School Construction Citizens' Bond Oversight Committee recommends that the Board of Education adopt an amendment to the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to define and approve a program to provide automated fire alarm dialer systems at 155 sites with a combined budget of \$2,952,750 as defined in Board Report 536-16/17, a copy of which is attached hereto in the form it was presented to the BOC and is incorporated herein by reference.
2. This resolution shall be transmitted to the Los Angeles Unified School District Board of Education and posted on the Oversight Committee's website.
3. The District is directed to track the above recommendation and to report on the adoption, rejection, or pending status of the recommendations as provided in section 6.2 of the Charter and Memorandum of Understanding between the Oversight Committee and the District.

Amendment to the Facilities Services Division Strategic Execution Plan to Define and Approve a Program to Provide Automated Fire Alarm Dialer Systems at 155 Sites

June 13, 2017

Facilities Services Division

Action Proposed:

Staff proposes that the Board of Education approve an amendment to the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to define and approve a program to provide automated fire alarm dialer systems at 155 sites. The total combined budget for this program is \$2,952,750. Work is anticipated to begin in the third quarter of 2017 and conclude by the fourth quarter of 2019.

Background:

On January 14, 2014, the Board of Education approved the establishment of the School Upgrade Program (SUP), the next phase of the District's Bond Program which will modernize, build and repair school facilities to improve student health, safety and educational quality. The Board's action approved the overarching goals and principles, funding sources, specific categories of need, and spending targets for the SUP.

The SUP includes a spending target to address "Critical School Repair and Safety Improvements to School Building Components." Projects developed under these categories of need are included in the Facilities Services Division Strategic Execution Plan. The proposed program addresses critical school repair needs which are necessary to improve student health, safety and educational quality.

The program will provide an automated fire alarm dialer system which includes a central monitoring station account. Connection to a central monitoring system is necessary to bring sites into compliance with District safety standards and to provide timely and reliable dispatch of emergency response personnel in the event of a fire at the site. The installation of required infrastructure and additional phone lines will provide direct contact with the central monitoring system and ensure the safety of school occupants and their facilities.

Expected Outcomes:

Staff anticipates that the Board of Education will approve the proposed program to address critical school repair needs that will improve student health, safety and educational quality.

Board Options and Consequences:

A "yes" vote will authorize staff to proceed with the expenditure of bond funds to undertake the proposed projects at 155 sites in accordance with the provisions set forth in Measures K, R, Y and Q. If the proposed action is not approved, bond funds will not be expended and critical school repair needs will remain unaddressed.

Policy Implications:

This action is consistent with the District's commitment to address unmet school facilities needs and provide students with a safe and healthy learning environment.

Budget Impact:

If this item is approved, \$2,952,750 in Bond Program funds earmarked specifically for critical school repair and safety improvements to school building components will be allocated for the installation of automated fire dialer systems at 155 sites.

Issues and Analysis:

It may be necessary to undertake feasibility studies, site analysis, scoping, and/or due diligence activities on the proposed projects prior to initiating design. As necessary, the Office of Environmental Health and Safety (OEHS) will evaluate the proposed projects in accordance with the California Environmental Quality Act (CEQA) to ensure compliance. If through the planning and design process it is determined that the proposed project scope(s) will not sufficiently address the critical need identified, the project scope, schedule and budget will be revised accordingly.

Bond Oversight Committee Recommendations:

This item was considered by the School Construction Bond Citizens' Oversight Committee (BOC) at its meeting of June 1, 2017. Staff has concluded that this proposed FSD SEP amendment will facilitate implementation of the FSD SEP, and therefore, it will not adversely affect the District's ability to successfully complete the FSD SEP.
