WHEREAS, District Staff proposes that the Board of Education amend the Information Technology Division (ITD) Strategic Execution Plan (SEP) to approve the definitions, allocate funds, and take the associated action(s) for the Device Refresh for Required Student Testing project as described in Attachments A, B, C and D.

WHEREAS, District Staff proposes the following actions:

- Move \$4,000,000 Learning Management System project (BOE Rpt 464-16/17) projected savings (originally allocated from the "Technology Infrastructure & Systems Upgrade" category of the School Upgrade Program (SUP)) to the Device Refresh for Required Student Testing project ("Upgrade and Equip with 21st Century Technology" category of the SUP).
- Approve execution of the Device Refresh for Required Student Testing project.

WHEREAS, the SUP includes a spending target to address "Upgrade and Equip with 21st Century Technology"; and

WHEREAS, the Device Refresh for Required Student Testing project will provide new mobile computing devices to 19 Primary Centers and 218 K-12 Schools to facilitate required State mandated testing; and

Amendment to the Information Technology Division Strategic Execution Plan to Approve the Device Refresh for Required Student Testing Project February 4, 2020 Information Technology Division

Action Proposed:

Staff proposes that the Board of Education amend the Information Technology Division (ITD) Strategic Execution Plan (SEP) to approve the definitions, allocate funds, and take the associated action(s) for the Device Refresh for Required Student Testing project as described in Attachments A, B, C, and D.

The proposed actions are as follows:

- Move \$4,000,000 Learning Management System project (BOE Rpt 464-16/17) projected savings (originally allocated from the "Technology Infrastructure & Systems Upgrade" category of the School Upgrade Program (SUP)) to the Device Refresh for Required Student Testing project ("Upgrade and Equip with 21st Century Technology" category of the SUP).
- Approve execution of the Device Refresh for Required Student Testing project.

Background:

On January 14, 2014, the Board of Education approved the establishment of the SUP, the next phase of the District's Bond Program, which will modernize, build and repair school facilities to improve student health, safety and educational quality. The Board's action approved the overarching goals and principles, funding sources, specific categories of need, and spending targets for the SUP. As proposed projects are developed, they are submitted to the Bond Oversight Committee (BOC) for consideration and the Board of Education for approval.

The SUP includes a spending target to address "Upgrade and Equip with 21st Century Technology." The intended outcomes of the proposed project to be executed within this spending target is:

• <u>Device Refresh for Required Student Testing project</u>: This project will provide new mobile computing devices to 19 Primary Centers and 218 K-12 Schools to facilitate required State mandated testing. \$4,000,000 (100% Bond).

Expected Outcomes:

Staff anticipates that the Board will amend the ITD SEP to define the new project described herein and reallocate \$4,000,000 of Bond Program funding. This project will help the District meet the State's mandate for online testing per the outlined timeline.

Board Options and Consequences:

Failure or delay of approval will postpone the execution and/or implementation of the proposed project and the associated benefit to the schools and students which includes jeopardizing the ability for students to take the

computer-based online tests within the State mandated timelines. The need and timing to procure and deploy the devices is immediate.

Policy Implications:

This action is consistent with the District's long-term goal to address unmet school needs as described in Proposition BB and Measures K, R, Y and Q.

Budget Impact:

The proposed project has a total budget of \$4,000,000 of Bond Program funding. This funding will be reallocated from the Learning Management System project projected savings. No new or additional funds are required.

Upon completion of the project, at the end of the devices' useful life, 5 years, there will be a need for an equivalent amount of funds to perform another refresh of devices for testing. The source of funding once identified will be amended to the ITD Strategic Execution Plan.

Student Impact:

The impact of this solution on students and testing is as follows:

- Provide increased opportunities for students and teachers to engage in practice tests provided by the State throughout the year.
- Provide schools more flexibility in creating testing schedules to meet the needs of the students.
- Student testing will take place with minimal restrictions based on access to devices.

Issues and Analysis:

The School Construction Bond Citizens' Oversight Committee (BOC), at its January 23, 2020 meeting, considered this item. Staff has concluded that this proposed SEP Amendment will facilitate the implementation of the ITD SEP, and therefore it will not adversely affect the District's ability to successfully complete the ITD SEP.

Project: Device Refresh for Required Student Testing

Budget: \$4,000,000 (100% Bond)

Introduction

When devices were provided to schools about 5 years ago to enable online student testing (BOE#129-13/14), the tests that needed to be taken online on a device were only in Mathematics and English Language Arts. This year, student tests required to be taken online on a device include English Language Proficiency for California, Science, California Spanish Assessment, and California Alternate Assessments. The table below shows more detail and the timeframe when these tests are required to be administered by schools.

The current devices at identified schools, included in Attachment D, that can be used for standardized tests are reaching the end of their useful life for student testing. Devices have a 5-year lifecycle and current devices are on their last year of compatible usage. It is projected that for the school year 2019-2020, the support for current devices will be removed and they will not be able to be used for standardized required state testing, which are mandated by state and federal law. Therefore, schools need to have compatible devices by the start of the 2019-2020 testing season, which began in late August. The need and timing to procure and deploy the devices is immediate.



Information Technology Strategic Execution Plan Amendments Project Definitions and Associated Actions Attachment A – BOE #248-19/20

Scope

This project will facilitate the procurement, delivery and deployment of 10,000 devices to replace obsolete and not compatible devices and to ensure that 218 K-12 schools and 19 primary centers have the mobile computing devices to conduct the required State mandated testing.

Expected Outcomes

The Device Refresh for Required Student Testing Project will enable students to complete the required State-mandated tests on devices compatible with completing the tests.

Expected project outcomes include:

- Systematic distribution of devices across 237 school sites and primary centers.
- Replacement of devices that are obsolete and not compatible with current required state-mandated tests at 237 school sites and primary centers.
- Sufficient devices at each school site for students to complete required state tests in the required timeframe.

Schedule

Estimated completion is April 2020. Schedule information is provided in Attachments D.




