Minutes from March 2012 approved without modifications. (No April meeting due to holiday)

Introduce new commissioner, Ric Loya, representing Bennett Keyser

- Presentation from Safe Schools/Healthy Students Washington Involving Neighborhoods: Joel Cisneros & GusTavo Guerra Vasquez. Created with federal assistance to support schools. Washington Prep, Harte Middle School, 11 Elementary schools, 2 private schools, Duke Ellington Continuation
- Has one Wellness Center, multiple mechanisms to engage stakeholders
- Healthy Kids data: 1/5 missed due to safety; 1/3 easy to get drugs; 12% of 7th graders considered suicide, 1/3 saw someone with a weapon
- Since WIN, students report: fights, depression and suicide, and other risks, coupled with increase in protective factors of help seeking behavior, academic engagement, feelings of safety

May 7, 2012

- No Haters Here cornerstones: Professional development, parent capacity building, administration collaboration, human relations development.
- Work with Facing History, ADL, Museum of Tolerance and parent center addressing effective communication skills, gang prevention and intervention, conflict mediation.
- St. John's Well Child Clinic is building a health center on campus.
- California Health Kids data improvement in rates fear of being target and rates of observing: getting beat up, rumors and lies, sexual jokes and harassment, fighting, pushing, LGBT harassment, racial harassment, (amount of change varies)
- Middle schools showed greater improvements than did the senior high school on these same variables.
- Funding ends in June 2013, when the Office of Safe and Healthy Schools will be closing. Initial budget was 2.2 million for the whole project.
- Concern about losing what has been built when the budget ends. Robin Toma requested that the Commission and the Board reflect on the extensive efforts that have been devoted to this cause. Racial, interethnic and gang tensions persist.
- Efforts to build sustainability include: Human Relations Leadership camp student retreats of 30-35 participants several times a year; creating an inventory for self-assessment of rubric for positive human relations on schools; formalizing a diversity council;
- Cohesive campuses are a strong protective factor against gang and racial conflicts.
- **Human Relations Awards** recognize all 5 applicants at the May 29th meeting, 2:00 in the Board Room. This will be in lieu of the Sunday June 3 event at Museum of Tolerance Realize that it is difficult to verify the authenticity of the applicants, this award is more of an "effort."
- **Future Meetings** Mark Abelsson cannot attend Monday meetings anymore. David Greene will assume chair position. Suggest no meeting in July and hold elections in August.
- Miramonte ES Commissioner Figel asked that the Commission take a position on the Miramonte teachers. Topic deferred for next meeting where 15 minutes will be allotted to discuss.
