Suspension and Attendance Data

Floyd Wheldon presented an analysis of 4 sample schools. Found a strong correlate between decrease in suspension and increase in attendance. The increase in attendance exceeded the decrease in suspension. It could be concluded that a change in school culture has far reaching impact.

There is still push back from teachers who cite UTLA contact allowing them to suspend from classroom.

Single Plan for Student Achievement Goal Matrix, Social Emotional Domain

Joyce Germaine Watts cited teachers who assert that they have never received an PD on classroom management and wondered what is done for teachers who have classroom management problems.

Joyce also asked presented a Single Plan for Student Achievement Goal Matrix, Social Emotional Domain from a sample school. Concerned that schools are not embracing Social Emotional concerns. Wonders what PDs are being offered for staff.

Human Relations Award

Bud Jacobs asked that the commissioners recommend secondary schools to apply for the awards.

Museum of Tolerance is working with student jurors from the SHADES program.
