Quorum was met. Meeting convened at 6:15 p.m.

December minutes were approved.

Ethnic Studies

Presentation by Angel Barrett, Sean Coppedge-Abajian and Javier San Roman regarding Ethnic Studies Program

Distributed copies of the resolution

In the initial planning stages of identifying schools/districts/teachers where Ethnic Studies is in place and selecting participants to be invited to be on the committee. Discussed the several considerations:

The course is a graduation requirement that has not yet being piloted Cost of 4 million for the pilot at 25 schools (5 in each ESC)

What classes and the corresponding teachers will be displaced in favor of Ethnic Studies?

What is impact of student access to electives and advanced placement courses

Current social studies framework of 2002 has minimal inclusion of Ethnic Studies The implementation time called for in the Board resolution does not allow adequate time for a course to be developed, piloted and implemented, especially if this is to be a 9th grade course.

Q – is this a menu of courses or will it be standardized? A- flexibility for schools to select what meets their needs. Currently have Asian, Latino & African American Maybe backed up to a 9th grade health course

Exploring the idea of revising current courses (e.g., History) to accommodate the Ethnic studies requirement

What about credit recovery for those who don't pass?

Blended learning and pilot schools have minimal leeway in their curriculum to accommodate another class.

The resolution time line requirements are challenging. E.g., if Ethnic studies is a 9th grade class, the 9th graders won't have an opportunity to take the class before the implementation deadline.

- Q what was the motivation for Ethnic studies? A El Rancho has 3 high schools that are heavily Latino. They wanted to enrich the curriculum to retain students, and help them learn about others cultures. Statewide movement for students who want a more culturally relevant and responsive curriculum.
- C Watts commented on the capability of teachers who will teach the courses and whether the apparent absence of a social justice theme. Wonders why social justice is considered controversial.

Response by Javier – social justice is a critical part of ethnic studies. There is a good reason to make it explicit but it is expressively runs through ethnic studies, as does intersectionality with gender, sexual orientation. Social Justice is a central plank of ethnic studies.

- Q was the social justice component soft-pedaled to get the resolution passed?
- Q who decides on the curriculum? A many have offered to help. Will work with teachers and professors. Currently focusing on the logistics.
- C Fajardo –Watch out for a too conservative view of social justice.
- Q Reynolds will each school use the same curriculum? A to be determined. Believes in multiple opportunities.
- C Abelsson intersectionality, sexuality, gender and religion must be included.
- Q-Train-how do gauge the depth of a subject? Will there be a rubric? A-will develop at the curriculum level. Important to develop the heart, not just the words
- C- de la Rosa There are 200 languages, 600 religions, et al in LA. everyone wants "their corner" to be prioritized. Would like to make recommendations.
- C Jacobs recommend Human Relations, Diversity & Equity to be part of the committee.
- Barrett 2 things floating a board member has proposed another resolution to address social justice without creating a parallel process. Wants to poll schools who have current social justice practices. Current email address Abarr5@lausd.net
- Q Tarrant are we digging our way into a hole we can't get out of? Can it be tweaked to give a better time frame to ensure implementation? A avoid being too restrictive. The "resolved" section of the resolution has items that do not align. A big frustration is that

Ethnic Studies was unsuccessful in the 70s and 90s. People are passionate enough to hold people accountable.

C - de la Rosa – consider the commission as critical friends and brain power to assist you See http://Ethnicstudiesnow.com

Restorative Justice – the Restorative Justice personnel are on Winter break. Will present at a future date.

Museum of Tolerance – invited the commissioners to participate in a session. Abelsson is available beginning mid May. Funding is available through June for a full day. Potentially May 21st and tag the commission meeting onto the day. Wittig Idea – have a facilitated meeting with commission and the ethnic studies implementation committee.
