Meeting open at 6:10 pm September minutes approved

Filmmaker Thomas Stewart showed his film, *Protect and Serve* about interactions between law enforcement and black men. This interactive documentary profiles his and his family's fears, concerns and thoughts.

Kakassy introduced a discussion on educational outreach the commission could recommend to schools on relationships between law enforcement and black men.

Southern Christian Leadership Conference has programs teaching people how to survive encounters with law enforcement.

Hernandez recommends that educational instruction should be talked about as a strategy.

Commissioners shared the highlights of their discussions with their board members of the proposed resolution to reinstate the office of human relations:

Ratliff was sympathetic but wanted specifics: how many staff members, what would be their duties and priorities?

Schmerelson open and said he'd bring it up with other board members and feels we need at least 7.

McKenna was supportive but prioritized other efforts.

Rodriguez was open. Recognized that the proposed cuts are for central office personnel only. Requested job descriptions with projected costs

Zimmer is favorably inclined toward human relations but not willing to go against the administrative priorities, as his understands them."

Vladovic wanted more rationale

Commission approved ad hoc committee to revise the proposed resolution on the staff of the Office of Human Relations. Kakassy, Perry, De La Rosa and Menjiar They will report back in November.

#### **Human Relations Awards**

Bud Jacobs drafted a new solicitation for the 2016/17 Human Relations Awards. The application was emailed to all commissioners. Desire proposals by April 1<sup>st</sup>. Will attempt to outreach at the HS principal's meeting, RJ specialists, board members and Lori Vollandt to assist in dissemination. Goal is to distribute in 10 days. Post on the website. Menijar will assist with corporate sponsorship

# **Guiding Strategies**

The Commission will review in November. JC will send the draft.

## Social Emotional Learning

Commissioners will attempt to visit one school to view social emotional learning. Kakassy and Ho both visited schools.

## **Executive Committee**

Comprised of the chair, co-chair, secretary and at-large plus Joey Hernandez. Will consider resuming meeting prior to the standard meeting. Staff liaison attends the executive committee meeting.

# Ad Hoc Committee on Educational Equity

Proposed by Kakassy to address educational gaps.

Abelsson cautions that this educational equity could be intertwined with the guiding strategies. Proposed waiting until the priorities are formalized

Watts observed that the commission is 99% human relations focused and is missing the consciousness toward equity

Toma recommend that the first step could be educating the Commission on educational equity and guiding strategies as its first priority

Hernandez recommends that the guiding principles be reviewed for their inclusion of educational equity

Wittig inquired as to District metrics on student achievement

Angela Hewlett is part of equity and acceleration

Motion approved to form an ad hoc committee on educational equity and its guiding strategies and report back in November. Participants; Allan, Hernandez, Dave Reynolds, Ray Lopez Michelle, Joyce,
