#### D. Office reports by

- a. Office of Human Relations, Diversity & Equity is now with Student Health and Human Services under the leadership of Erika Torres. Ms. Torres has been apprised of the Commission and has an open invitation to attend.
  - Brief discussion on principals' accountability for student engagement.
- b. Social Emotional Learning board approved the resolution The resolution was actionable to have awareness campaigns and equipping the SEL team. Recommend invite Dr. Vollandt or Gipson to address at another meeting.
- c. Ethnic Studies ask Kieley Jackson to address.
- d. Educational Equity Indian Education receives Title VI federal funding. Wilson pointed out the high drop out and stagnant academic performance of Native Americans, and the under

preparation of students for college. Currently headed up by Timothy Vizthum. The \$173K funding is a teacher specialist.

- E. Presentation by Karen Ryback, Executive Director, Federal & State Education Programs
  - **a.** Budget was created conservatively at \$259 million because the amount of federal money that would be funded was unknown. The revised allocation is \$366,559, 000.
  - **b.** Funding considers the poverty level of the students, however, allocation to individual students is based on need. 80% of students are identified as Title I. LAUSD schools are funded in rank order of income. Ryback recognized the distress to staff with potential layoffs. Ethnicity is not a considered.
  - c. The unknown funding amount was due to Congress not acting in a timely manner.
  - d. Other funds are from targeted student populations, carry over from general funds
  - **e.** In terms of revisiting the allocation of funds based on needs, targeted student populations are based on equity needs index. The Superintendent is considering revisiting that. Speak with Pedro Salcedo of Government Relations.
  - **f.** The human relations component is the fracturing of communities based on the tentative funding.
  - **g.** Kakassy, Perry and Watts will author a resolution of empathy and caring. Jacobs recommends they get additional information before proceeding.

#### F. Commission membership

- **a.** Michele Wittig has resigned the commission and would like to remain in an advisory position.
- **b.** David Reynolds has is the new National Director of PD for ADL. Annie Ortega is stepping in as the new commissioner. Annie Ortega has a background in community education with Didi Hirsch with a specialization in substance abuse.
- c. Karras Wilson part of Ethnic studies and a guidance counselor for Native American youth. Bemoaned the current academic stagnation. Wants preferential treatment for Native American students due to under-representation. Funding is based on number of students who self-identify as Indian on the 506 form based on parent/grandparent enrolled members of one of 569 recognized tribe. However each tribe sets its own standards as to membership qualification. Keith Abrams is the new contact person.
  - Consider establishing an ad hoc meeting to dig deeper into Native American students.
- G. Christine Gonzales-Palmer accepted position as secretary.
- H. Human relations awards
  - **a.** This year, expand partnership with RJ and SEL groups.
