a. Housing Task Force

June Minutes approved

On hold. There is no coordinator in homeless in SHHS. The head of facilities retired, but Reseda HS is piloting a laundry facility for students with unstable housing. An adult at the school will do the laundry for the students. Reseda is exceptionally high for unstable housing. Met with David Baca. Exploring a partnership with the community wherein families could use a tap card at local laundromats. Schools may like the idea but identifying the actual hook ups and plumbing has been a concern.

b. Human Relations Awards

Susy is writing up bi-monthly profiles for select recipients. The awardees will be included in the minutes and posted on Schoology, AALA, and DOI and principal newsletter.

c. Educational Equity and School Culture

Land acknowledgment. The Commission discussed sponsoring a land acknowledgment. Judy reached out to LAUSD's Indian Education Unit to adopt one for the district who was very supportive. Proposed to have draft resolution to the Board for November Native American History month. Gary will help draft a resolution.

Inquired about the strategic planning process. Museum of Tolerance offered to sponsor another retreat. Explored how the commission defines "equity." "Gaps in access, opportunity and outcomes, with the intention of closing gaps."

BSAP is partially funded to close the achievement gap. 90% of LAUSD Black students did not meet the math standards (compared to 72% of the district). Consistent failure rate. DeSantis and white nationalist have complained to Office of Civil Rights that targeted interventions are race-based.

- d. Civic Engagement reaching out to colleagues during this election year. Might contact the Student Empowerment Unit.
- e. Office of Human Relations, Diversity & Equity there is an increase in antigay sentiments. HRDE has a skills-based training on responding to LGBT bias. LA HRC wants to create a letter for parents. Museum of Tolerance offered to host a focus group on responding to bias.
