Across the country, there are broader requests for opt outs	

Watts: at this point there is no indication that the Mahmoud v. Taylor decision will extend to secondary.

Discussed book bannings: In the 1982 Board of Education, Island Trees Union Free School District No. 26 v. Pico, the Supreme Court considered whether a school board's removal of books from a school library violated students' First Amendment right to access information. The Court ruled that school boards cannot remove books from school libraries solely because they dislike the ideas or viewpoints presented in those books.

Discussed the importance of crossing the divide and differentiating between not liking someone's politics but still liking the person. Cannot fall into dehumanizing others. Need to model building alliances.

Shared about Braver Angels <a href="https://braverangels.org/">https://braverangels.org/</a> which teaches strategies to engage in dialogue.

Watts asked about the faith community's visibility.

Marroquin asked about the micro credential & the liaisons and parent trainings re LGBTQ matters are presented at schools. ReachLA offered to share resources
