BOARD REPORT

Action Proposed: Staff proposes that the Board of Education amend the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to cancel 633 projects listed in Attachment A and to unfund 288 projects listed in Attachment B.

Background: Nearly 15 years have passed since voters approved the District's first local bond measure, Proposition BB. Since that time, \$19.5 Billion in capital funding has been secured for the current Bond Program. This Program is funded primarily by \$13.6 Billion of local school bond measure proceeds that have been leveraged to secure approximately \$5.9 Billion in matching funds resulting in the development of even more capital improvement projects than anticipated. This has enabled more than 26,000 construction projects to be established and added to the FSD-SEP. Over this same time period, more than 25,000 projects have been successfully completed and approximately 2,000 projects remain in the SEP as active.

Because cancellation and unfunding actions have come to the Board on an infrequent basis, a number of projects have accumulated in the SEP that are now deemed either unnecessary or cost prohibitive. The cleanup action proposed in this Board Report will cancel 633 projects that are no longer needed or feasible as defined (Attachment A) and unfund an additional 288 projects (Attachment B) that are still needed but do not have the funding necessary to complete the needed scope. These unfunded projects will remain in the SEP as unfunded requirements that could be funded when future money becomes available. This cancellation and unfunding action is necessary for the FSD-SEP to be an accurate reflection of the remaining work that will be executed as part of the current Bond Program.

Cancelled projects fall into the following categories:

Portable Buildings Certification and Access Compliance - 249/44 projects

These projects were defined and designs were submitted to the Division of the State Architect (DSA) more than seven years ago. Site conditions have changed significantly and the current projects do not reflect the work that needs to be done. New scope, schedule, budget and DSA approval are all necessary if the underlying requirement still exists.

Early Education Centers - 104 projects

The Division of Early Childhood Education has requested cancellation of 104 projects because they do not currently reflect the priorities for project work at these sites.

Portable Removals - 47 projects

These projects that were defined to remove portables that are now required for other use (i.e. Charter co-location, administrative use) or in some cases, the portable is scheduled for removal as part of another project's scope.

Measure K - Local District (LD) Defined - 40 projects

Requirement(s) no longer exists for 40 projects (Place portable classrooms, office modifications, paving, lunch shelters, etc.). Cancellation forms have been signed by each Principal, Regional Facilities Director (RFD) and LD Superintendent.

Alterations & Improvements - 40 projects

These projects were previously identified by the LD Superintendent and are no longer being requested for various reasons. Cancellation forms for these projects have been signed by each Principal, RFD, and LD Superintendent.

Major Repairs - 25 projects

Requirement(s) no longer exists for these major repair projects (Paving, HVAC, Roofing, Fire Alarm, etc.). Cancellation forms have been signed by each RFD and LD Superintendent.

Seismic Retrofit of Portables - 22 projects

These projects are associated with portables that have either been removed or are scheduled to be removed in 2012.

Board Member Priority - 20 projects

These projects were previously identified by the Board Member Office and are no longer being requested for various reasons. Cancellation forms have been signed by each Board Member.

Career Academies - 15 projects

These projects were defined and scoped to be funded with Qualified Zone Academy Bonds (GF repayment) that were never sold by the CFO's office.

BB Program - 14 projects

The requirement(s) that generated these projects no longer exists (2 Fire Alarms, 7 HVAC, 4 Plumbing, 1 Security Grill). Cancellation forms have been signed by each Regional Facilities Director and LD Superintendent.

Joint Use - 8 projects

These mobile health clinic projects no longer have the necessary partner contributions in place and as such are no longer viable.

Fire Alarms - 4 projects

The requirement(s) that generated these projects no longer exist. Cancellation forms have been signed by each Regional Facilities Director and LD Superintendent.

Core Facilities - 1 project

Burroughs Middle School requested the cancellation of this project to place a sanitary building because there is a lack of available space at the site. The need for additional restrooms will be incorporated into the Master Plan for this site.

Unfunded projects fall into the following categories:

Measure K - LD Defined - 129 projects

These projects fall into two categories: Scope requirement and estimated cost are now significantly greater than available budget or RFD and/or LD Superintendent have identified other Measure K projects as higher priorities and chose to unfund this work.

Major Repairs - 119 projects

Funds associated with major repair projects were reallocated to the Two-Semester Neighborhood School Program in 2007 to ensure its successful completion. Many of these projects were unfunded as part of the 2007 reallocation effort and the remainder are unfunded because the scope and current estimated cost are greater than the available budget.

Measure Y - Basic Repairs + Deferred Maintenance - 34 projects

This program was created with matching bond and State Deferred Maintenance funding. These project requirements exist but funding is no longer available for execution.

BB Program - 3 projects

These projects were all defined approximately 15 years ago. The design process uncovered additional necessary scope leading to cost estimates that greatly exceed current budgets.

Alterations & Improvements - 2 projects

Project cost estimates exceed available budget. Projects are being unfunded at the request of the LD.

Core Facilities - 1 project

This project to place a new sanitary building at Lawrence Middle School is being unfunded as a result of reduced student population. The need for additional restrooms will be reviewed as part of the master planning effort for this site. Additionally, this school will be relieved by the opening of the Valley Region Middle School #3 project in August 2012.

Expected Outcomes: Approval of the proposed action will enable staff to produce a 2012 FSD-SEP that accurately reflects the remaining work that will be executed as part of the current Bond Program.

Board Options and Consequences: If the Board approves the proposed action, staff will proceed with cancelling 633 projects and removing them from the SEP, and placing 288 projects on the unfunded list. If the Board does not approve the proposed action, projects that are no longer required, viable to execute as defined, or do not have adequate funding to execute will continue to be considered active projects and will appear in the SEP and be reported on in all status reports and audits.

All of these projects are currently inactive. If the Board does not approve this proposed action, the projects will remain inactive. For projects with an existing underlying requirement(s), only when additional funding is identified and an accurate scope, schedule and budget is established will the project be executed.

Policy Implications: The requested action does not change current District policies.

Budget Impact: Bond Program funds are associated with the projects included in this proposed action. There is no impact to the General Fund. The majority of the project funds have been expended or have already been redirected to another project within the appropriate Board-prioritized program. The budget, estimate to complete and commitments on each individual project budget will need to be reviewed and analyzed in order to determine the amount of, if any, budget that can be made available for additional projects. Should available funding be identified, it will be returned to the Board-prioritized program that the cancelled/unfunded project was associated with.

Issues and Analysis: The cancellation and unfunding of these projects will remove them from the SEP which will maintain schedule, total project count, and overall program cost accuracy. Instances have been identified where site conditions no longer dictate the need for the originally identified improvements for certain projects.

In an effort to minimize confusion and ensure transparency, processes and procedures have been implemented to deal with any future changes in projects that necessitate cancellation or unfunding. Only with written approval from the appropriate owners/clients and the subsequent review by the Citizens' Bond Oversight Committee and approval by the Board of Education, will a project be cancelled or unfunded and funds made available for other higher priority projects.

Bond Oversight Committee Recommendations: This item was considered by the School Construction Bond Citizens' Oversight Committee (BOC) at its meeting on March 21, 2012. The BOC adopted the attached resolution by a vote of "10" ayes and "0" nays.

Staff has concluded that this proposed SEP amendment will help facilitate implementation of the FSD SEP, and therefore, it will not adversely affect the District's ability to successfully complete the SEP.

RESOLUTION 2012-07
BOARD REPORT NO. 201-11/12
**AMENDMENT TO THE FACILITIES SERVICES DIVISION STRATEGIC
EXECUTION PLAN TO CANCEL 633 AND UNFUND 288 PROJECTS**

WHEREAS, District staff proposes in Board Report No. 201-11/12 that the Board of Education amend the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to cancel 633 projects and unfund 288 projects, and

WHEREAS, Nearly 15 years have passed since voters approved the District's first local bond measure, Proposition BB. Since that time, \$19.5 Billion in capital funding has been secured for the current Bond Program. This Program is funded primarily by \$13.6 Billion of local school bond measure proceeds that have been leveraged to secure approximately \$5.9 Billion in matching funds resulting in the development of even more capital improvement projects than anticipated. This has enabled more than 26,000 construction projects to be established and added to the FSD-SEP, and

WHEREAS, Over this same time period, more than 25,000 projects have been successfully completed and approximately 2,000 projects remain in the SEP as active, and

WHEREAS, Because cancellation and unfunding actions have come to the Board on an infrequent basis, a number of projects have accumulated in the SEP that are now deemed either unnecessary or cost prohibitive, and

WHEREAS, The cleanup action proposed in Board Report No. 201-11/12, will cancel 633 projects that are no longer needed or feasible as defined and unfund an additional 288 projects that are still needed but do not have

the funding necessary to complete the needed scope. These unfunded projects will remain in the SEP as unfunded requirements that could be funded when future money becomes available, and

WHEREAS, This cancellation and unfunding action is necessary for the FSD-SEP to be an accurate reflection of the remaining work that will be executed as part of the current Bond Program, and

WHEREAS, Cancelled projects fall into the following categories: Portable Buildings Certification and Access Compliance (249/44 projects), Early Education Centers (104 projects), Portable Removals (47 projects), Measure K - Local District (LD) Defined (40 projects), Alterations & Improvements (40 projects), Major Repairs (25 projects), Seismic Retrofit of Portables (22 projects), Board Member Priority (20 projects), Career Academies (15 projects), BB Program (14 projects), Joint Use (8 projects), Fire Alarms (4 projects), and Core Facilities (1 project), and

WHEREAS, Unfunded projects fall into the following categories: Measure K - LD Defined (129 projects), Major Repairs (119 projects), Measure Y - Basic Repairs + Deferred Maintenance (34 projects), BB Program (3 projects), Alterations & Improvements (2 projects), and Core Facilities (1 project), and

WHEREAS, All of these projects are currently inactive. If the Board does not approve this proposed action, the projects will remain inactive. For projects with an existing underlying requirement(s), only when additional funding is identified and an accurate scope, schedule and budget is established will the project be executed, and

WHEREAS, This FSD-SEP amendment will enable staff to cancel 633 projects and remove them from the SEP, and place 288 projects on the unfunded list. Ultimately, it will enable staff to produce a 2012 FSD-SEP that accurately reflects the remaining work that will be executed as part of the current Bond Program, and

WHEREAS, If this amendment is not approved, projects that are no longer required, viable to execute as defined, or do not have adequate funding to execute will continue to be considered active projects and will appear in the SEP and be reported on in all status reports and audits, and

WHEREAS, The majority of the project funds have been expended or have already been redirected to another project within the appropriate Board-prioritized program. The budget, estimate to complete and commitments on each individual project budget will need to be reviewed and analyzed in order to determine the amount of, if any, budget that can be made available for additional projects. Should available funding be identified, it will be returned to the Board-prioritized program that the cancelled/unfunded project was associated with, and

WHEREAS, In an effort to minimize confusion and ensure transparency, processes and procedures have been implemented to deal with any future changes in projects that necessitate cancellation or unfunding. Only with written approval from the appropriate owners/clients and the subsequent review by the Citizens' Bond Oversight Committee and approval by the Board of Education, will a project budget be decreased and funds made available for other higher priority projects, and

WHEREAS, District staff has concluded that this proposed SEP amendment will help facilitate implementation of the SEP, and therefore, it will not adversely affect the District's ability to successfully complete the SEP.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The School Construction Bond Citizens' Oversight Committee (BOC) recommends that the Board of Education adopt an amendment to the FSD-SEP to cancel 633 projects listed and unfund 288 projects as described herein and in Board Report No. 201-11/12, a copy of which is attached hereto in the form it was presented to the BOC.
2. This resolution shall be transmitted to the Los Angeles Unified School District Board of Education and posted on the BOC's website.
3. That a written response, as required by the Charter and Memorandum of Understanding between the District and the BOC shall be provided to the BOC within 30 days, reporting either action taken or proposed to be taken in response to this resolution and each recommendation herein.




