BOARD REPORT Action Proposed:

Staff proposes that the Board of Education approve an amendment to the Facilities Services Division Strategic Execution Plan to define the San Pedro High School Baseball Field Upgrade Project. This project will create a new 70 foot high barrier, which will ensure compliance with a recent Superior Court decision.

Background:

The San Pedro High School baseball field is located on the north side of the campus. It has resided in this particular location for approximately 12 years, along with a 16 foot high perimeter fence that was constructed along the boundary. The distance from home plate to the right field fence is 266 feet, which is less than the California Interscholastic Federation's recommended distance of 320 feet. As a result, baseballs have cleared the fence and entered the property of an apartment building. In 2006, the District constructed a 45 foot high barrier fence as a result of complaints from the property owner. Despite the higher barrier, baseballs continued to enter the apartment property, at times striking the building. In December 2009, the property owner filed suit against the District alleging the existence of a nuisance (*Josh Properties II, LLC v. LAUSD*).

On July 14, 2011, the Superior Court issued an interim order in the case, which ordered the District to "begin the preliminary process necessary to construct a 70 foot fence extending 165 feet from right field to right center field (i.e. a sufficient distance to provide a barrier between defendant's field and plaintiff's building)." Further, this preliminary process was to include "all action necessary to enable construction to commence as soon as practical after the hearing ... date should the Court determine that the nuisance has not been abated." At the Court's direction, LAUSD has secured Division of State Architect (DSA) approval on plans and specifications to erect a barrier that will stand 70 feet tall.

The Superior Court judge conducted an advisory jury trial on this matter on August 3, 2012. The jury found in favor of the plaintiff, six-to-two. As a result, the court issued an order to the District to abate the nuisance.

During the course of the trial, the District's expert testimony was admitted into evidence that stated raising the barrier to a height of 70 feet would reduce the number of balls clearing the fence by 98 percent. The judge has ruled that the construction of a 70-foot barrier is an acceptable remedy to abate the nuisance.

Construction is anticipated to begin in the fourth quarter of 2012 and conclude in the third quarter of 2013. The project is located in Educational Service Center South and Board District 7 (Dr. Richard Vladovic).

Expected Outcomes: If the Board of Education approves the proposed action, staff will proceed

with the construction of the proposed San Pedro High School Baseball Upgrade Project in accordance with DSA- approved drawings. Once completed, the District will be in compliance with the associated Superior

Court decision.

Board Options and Consequences:

A "yes" vote will authorize construction of the San Pedro High School Baseball Field Upgrade Project. The project will extend the existing outfield poles and construct a 70 foot net. If the proposed project is not approved, the existing field will be unusable for baseball activities and the

District would not be in compliance with the Court order.

Policy Implications:

These actions are consistent with the District's commitment to address

unmet school facilities needs and provide students with a safe and healthy

learning environment.

Budget Impact: The project budget is \$365,183, which includes \$25,180 of previously

incurred costs related to the initial scoping, planning and design of the project. The proposed project is funded by Bond Program funds. This

project will not involve any General Fund expenditures.

Issues and Analysis: This project is being proposed as a result of a recent Superior Court

decision that determined a nuisance existed, and required it be abated.

Bond Oversight Committee

Recommendations:

This item was considered by the School Construction Bond Citizens' Oversight Committee (BOC) at its meeting of September 15, 2012. The BOC adopted the attached resolution by a vote of 11 ayes and 0 nays.

Staff has concluded that this proposed SEP amendment will facilitate implementation of the SEP, and therefore it will not adversely affect the

District's ability to successfully complete the SEP.
