### BOARD REPORT

**Action Proposed:** Staff proposes that the Board of Education amend the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to redefine and approve the school Information Technology (IT) network infrastructure and equipment upgrade project at Helen Bernstein High School to include construction. The project is currently defined and approved with a scope including project design and installation of scalable fiber only (BOE #248-13/14, adopted on February 11, 2014).

Construction is anticipated to begin in the second quarter of 2014 and be completed in the third quarter of 2014. The total project budget is \$1,505,680, of which \$178,640 was previously approved as part of the initial project definition.

Staff further proposes that the Board of Education authorize the Chief Facilities Executive and/or his designee to execute all instruments necessary to execute the Board-approved scope associated with the project, including the purchase of equipment and materials necessary for project execution.

**Background:** The construction of Helen Bernstein High School was initiated in 2004, and completed in 2008, and is in need of upgraded IT network infrastructure and equipment necessary to deliver today's educational program to the over 1,500 students currently enrolled at the site. The proposed project redefinition will enable Phase 1L of the Common Core Technology Project to be implemented at Helen Bernstein High School.

Helen Bernstein High School is located in Board District 4 (Zimmer) part of the Intensive Support and Innovation Center Educational Service Center.

- Expected Outcomes:** Approval of this proposed action and the subsequent investment in upgrades to aging IT network infrastructure and obsolete equipment at Helen Bernstein High School.
- Board Options and Consequences:** Approval of the proposed action will authorize staff to construct a school IT network infrastructure and equipment upgrade project at Helen Bernstein High School. If the proposed action is not approved, the upgrade of the network infrastructure and equipment at Helen Bernstein High School will not be constructed, thereby preventing student's access to the latest instructional initiatives made available via the installation of wireless network technology.
- Policy Implications:** This action is consistent with the District's long-term goal to address unmet school facilities needs as described in Proposition BB and Measures K, R, Y and Q.
- Budget Impact:** This proposed action impacts Bond Program funds only. The total project budget is \$1,505,680, of which \$178,640 was previously approved as part of the initial project definition (BOE #248-13/14, adopted on February 11, 2014). The proposed action will allocate the remaining \$1,327,040 necessary to construct the project. Funding will be provided by Bond Program funds allocated to IT School Network Infrastructure Upgrades Executed by FSD in the School Upgrade Program (SUP).
- Issues and Analysis:** Advancements in technology are increasing the options available to teachers to deliver instructional initiatives and changing the way students learn and perform. However, the vast majority of Local Area Network (LAN) projects undertaken over the past decade occurred prior to the introduction of the high throughput and wireless technologies that are used today, and upon which the current instructional technologies depend.
- Bond Oversight Committee Recommendations:** This item was considered by the School Construction Bond Citizens' Oversight Committee (BOC) at its meeting on March 27, 2014. Staff has concluded that this proposed FSD-SEP Amendment will facilitate the implementation of the FSD-SEP, and therefore it will not adversely affect the District's ability to successfully complete the FSD-SEP.




