	Reviewer C	YES	The major positive of this proposal is the infusion of thematic communities with a link to college/career readiness. Many of the ideas seem to only satisfy minimum requirements and fail to seize the opportunity to create something new, different, and more responsive. Some of the individual pieces are strong, but it would be good to see all components more clearly contribute to a systemic change in the school.
Applicant Los Angeles HS Internal Redesign Team	Reviewer D	YES	 The following points demonstrate that Los Angeles High School is headed in the right direction: Los Angeles High School has shown a 73 point increase in API in the last two years. Their English Learners are scoring more proficient on the CELDT and passing English classes with a "C" or better at a higher rate than the district average over the past two years. Students in the Special Education Program who scored proficient and advanced on the CST, in the last two years are also above the district average. Pg.11 If the preceding points are combined with the implementation of proven game changers such as: Small Learning Communities, Professional Learning Communities, an innovative 2x8 schedule, advisories and a collaborative school based management governance, high standards set for <u>all</u> students, (Appendix U), strategic focus on instruction pp.33-36, and a growing parent volunteer program pg.57, there is enough to suggest that the school will continue to grow academically. Strengths: Professional Development Calendar with sessions and instructional focus is already developed for the Spring of 2012 to the Spring of 2013.(Appendix V) Commitment Forms for Students, Parents, Teachers/Staff, Community and Administrators. (Appendix X) makes every member of the school community accountable

		Area of Concern: According to Appendix AA, the faculty advisory vote shows that over 61% of the faculty voted "NO" the integration of the 9 th grade house into the other Career Academies. The essential element of this plan is the integration of 9 th grade house into the other academies. It is important that teachers understand and take ownership of these new proposals in order to make positive shifts in their school's culture.
