Political Activities & Use of District Resources

The Tuesday, March 3rd Primary Nominating Election for LAUSD Board Districts 1, 3, 5 and 7 is quickly approaching. While it's every individual's right to participate in the democratic process, as public officials we must be mindful that public resources are not used in support of our personal views. The law, LAUSD policies and Board Rules are explicit in this area. To assist you in understanding your responsibilities as a public official, please review "LAUSD's Election Tip Sheet." The tip sheet is also posted on the Political Activities page of the Ethics Office website.



Further, if your school or office utilizes social media (Facebook, Twitter, etc.) to communicate with parents, community members or employees regarding LAUSD business, be aware that the posting of explicit or implied endorsements of political candidates is prohibited. <u>Bulletin 999.13 - Responsible Use Policy (RUP) for District Computer and Network Systems</u>, <u>Attachment B</u> stipulates, "The use of the District network for illegal, political, or commercial purposes is strictly forbidden."

- If you have not yet done so, please submit your December Imprest reconciliation report as soon as possible. The next quarterly report will be due on April 20th.
- Please continue to process receivers for POs as soon as you receive good/services to ensure that all receivers are processed in a timely manner and all purchase orders are charged to the current fiscal year.

PROBATIONARY 1 TEACHERS:

All principals and certificated administrators will be required to decide if they will provide "Affirmative Endorsement" to the probationary and provisional certificated employees assigned to their site.

- For Probationary 1 and Provisional employees, the Workforce Data Analysis Unit will email rosters to Principals. To obtain a copy of your roster, please email: affirmdecision@lausd.net
- Endorsement decisions for Probationary 1 employees will need to be submitted to the Local District Superintendent and/or Supervising Administrator by March 2, 2020.
- The Local District Superintendent and/or Supervising Administrator will sign the forms by March 9, 2020.

WARNING OF POSSIBLE BELOW STANDARD EVALUATION (MID YEAR WARNING)

Employees who might receive an overall **Below Standard Evaluation** should be given sufficient advance notice. Administrators are to provide written recommendations and assistance for improvement through written conference memos and should also include a warning as to the consequences of failure to improve. Such notice is to be given with sufficient time for the employee to implement the assistance provided. Please, remember to <u>contact</u> your Staff Relations Field Director if you are working with a teacher who may receive a BSE.

Introducing LD Central Specialized Student Services Staff

LD Central Specialized Student Services staff are happy to be located on the 11th Floor. Fifty-six A-G and Specialized Student Services Counselors provide an array of services to all LD Central school sites. A-G Counselors provide targeted case management for off-track Tier 2 and 3 students to meet A-G and culmination graduation requirements, teach high school preparedness and support transitioning students from middle to high school. Specialized Student Population

(SSP) Counselors provide case management services to foster youth, students experiencing homelessness and students involved in the juvenile justice system with the focus of increasing attendance rates and school engagement, increasing academic attendance/graduation rates and increasing school stability. Annually, counselors participate in the Homeless Education Office (HEO) Sponsor-A-Family event. Families in need of support during the holiday season are referred to be sponsored by the community. This December, 334 families district -wide were sponsored through referrals made by Specialized Student Population Counselors. Fifty of these families were from LD Central.
